2. [REDACTED] LEGISLATION I spoke with Mr. Stan Taylor, Senate Select Committee on Intelligence staff, and confirmed that Senator Adlai E. Stevenson (D., Ill.) is having an options paper prepared on various alternatives for action on S. 2236, the "Anti-Terrorism" legislation. (See Memorandum for the Record for details.)

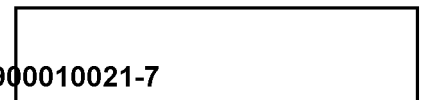
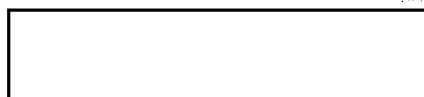

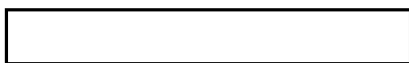

11. [REDACTED] LIAISON Received a call from Robert E. Redding, Ford Motor Company, who was wondering "about the extent to which their Company might relate to CIA for publications of research, etc. which we produce which would be of interest to a private Company like theirs." I referred him to the Document Expediting (DOCEX) Project, Library of Congress, explaining that he could obtain on a subscription basis unclassified CIA publications. He said this was just the type of information he was looking for and thanked me.

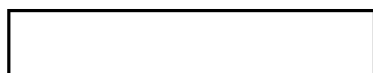
