	1. I have reviewed both the current and draft regulation. The latter is a vast improvement over the former, since it legitimizes the supervisory function that many SPS personnel perform and is a much more straightforward piece of writing.
STATINTL	2. While I understand the reasoning behind the minimum experience requirement occasions may arise when an individual being considered for a position is fully capable of assuming SPS level responsibilities but lacks the required seven years of experience. To accommodate such situations, I suggest the revised regulation be modified to permit Agency components to assign individuals with less than seven years experience to SPS positions. Exceptions of this sort would have to be fully justified in writing and would need the concurrence and approval of the appropriate deputy director, Director of Personnel and the Director of Central Intelligence.
