3. Action: Agreed to return to Committee for redrafting, the list of those to be notified to be substantially reduced.

Progress Report (IAC-PR-28)

4. <u>Action</u>: Agreed that completion of NIE-70, "Conditions and Trends in the Middle East Affecting U. S. Security," should be accelerated, subject only to the demands of outstanding Soviet estimates.

Proposed Estimate on Albania

5. <u>Action</u>: At DCI's request, agreed to initiate an estimate, priority urgent, of the consequences of the overthrow of the present Albanian regime by a pro-Western regime.
