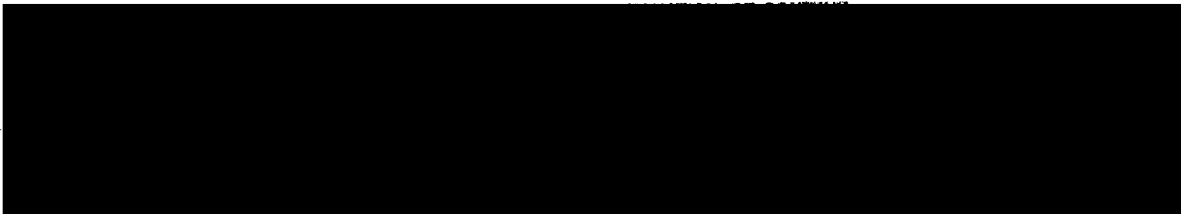

1. SCSCOREX S.A. (Societe Commerciale et d'Exportation), a Swiss trading company with a capital of 500,000 Swiss francs, intends to import American pharmaceutical products and other American goods for sale in Switzerland, Hungary and the Balkans, according to source. The company also wants to purchase Austrian goods against delivery of other goods. Source indicated that the company would pay, if the Austrians desired, in dollars or other free currencies.

2. Source reports the following information about directors of SCSCOREX S.A.:

Dr. Max Kinche, lawyer, about 40 years old;

Alexander Petitpierre, born 15 October 1906, half-brother of Max Petitpierre, Foreign Minister of Switzerland, and of the new director of the Credit Suisse at Lausanne.

Maurice Gony, born 1911, who resides in 5 avenue Bertrand, Geneva. He is director of about 40 companies.

Jacques Kinche, born 18 November 1908 in St. Gall, Switzerland, lives in 2 boulevard de Grancy, Lausanne. He is a former bank clerk. Since 1932 he managed MEJOR S.A. (Comment:--Kinche is said to lack a good reputation in Swiss business circles).

3. Source reports that the only director of the company is Jean Francken, a solicitor of Lausanne. The company has been actively transporting goods to foreign countries, especially Hungary.

4. Sokoline, former member of the Soviet Delegation to the League of Nations, will collaborate with SCSCOREX S.A., source reports, as adviser for Russian business.
