

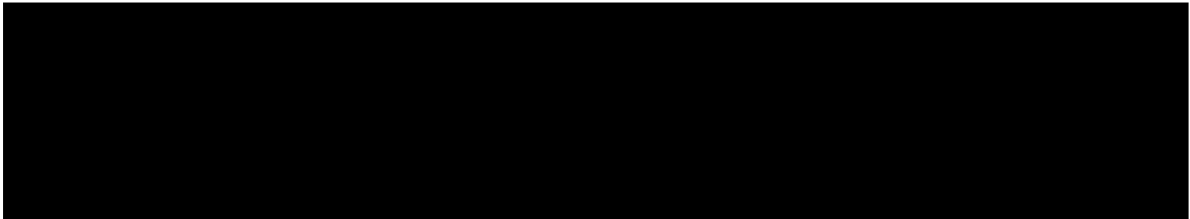

1. Ivica Krsul claims to be President of the Union Yugooslava in La Paz, Bolivia, an organization which was recently formed by Yugoslavs who had withdrawn from the Union Eslava. Krsul stated that this new organization is anti-Communist, and that the remainder of the Union Eslava, since the withdrawal of the Yugoslavs, is Communist-dominated.* According to Krsul, most of the La Paz Yugoslav colony is with him, except for Pavel Segvic, who was one of the leaders of the Union Eslava. Krsul and Segvic have recently had a falling out.
2. Krsul intends to fight the present Government of Yugoslavia. To carry out this plan, he has announced the formation of two corporations: Corporacion Internacional Financiera de Espectaculos, S.A., and Bolivia Sono Film, which will have as their purpose the creation of a native Bolivian film industry. The companies will attempt to make documentary films based upon the customs, natural beauty, and native literature of Bolivia. Krsul is being assisted in his cinematic endeavors by an Argentine national named Rudy Musera.
3. Krsul also plans to construct a broadcasting station in La Paz which will be stronger than anything known locally. His new station, to be located in the Edificio Yugooslavo, will be one of 15 kilowatt strength and will be part of his propaganda chain beamed at Yugoslavia. Stations are also envisaged for Chile and Argentina.
