**MEMORANDUM FOR ACTING DIRECTOR, UNITED STATES ARMS
CONTROL AND DISARMAMENT AGENCY**

SUBJECT: Declassification of Seismic Data

1. The following is in reply to your memorandum dated 19 March 1963, requesting the declassification of data [redacted]

[redacted] to the Deputy Director, Bureau of Intelligence and Research (INR), Department of State, dated 20 March 1963, indicates that declassification of pages 10 through 17 and the table of data from your testimony before the Joint Committee on Atomic Energy on 25 February 1963 would meet your requirements in this regard.

2. The United States Intelligence Board has determined that these portions of your testimony before the Joint Committee on Atomic Energy, as amended by Dr. Long's memorandum to the Chairman, Joint Atomic Energy Intelligence Committee, dated 22 April 1963, could be released without compromising the U.S. Atomic Energy Detection System or other intelligence sources, and thus public release would not constitute a problem from a security standpoint. The United States Intelligence Board, however, suggests that prior to release the testimony should be reviewed for technical accuracy by appropriate organizations in the Department of Defense and the Atomic Energy Commission.
