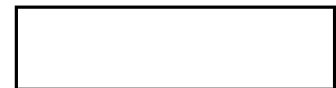


2. A Committee staff member assisted in arranging a briefing at CIA Headquarters for the judges of the United States Foreign Intelligence Surveillance Court and Court of Review. The briefing covered the role of the DCI and the Intelligence Community, CIA organization, mission, and relationship to the Community, the intelligence requirements, analysis and dissemination process in support of the President and other policy makers, security procedures, and the screening of proposals for electronic surveillance for foreign intelligence purposes.

Arrangements were made for the chairman of the Committee's Computer Security Subcommittee to have observer status on the newly formed working group on computer security of the National Communications Security Committee. This relationship will enhance the interchange of information between the parent committees and assure against duplication of effort in computer security matters.

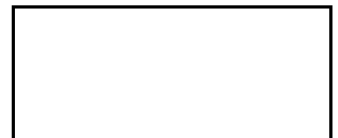
