MEMORANDUM FOR THE RECORD

SUBJECT: 23 February 1967 Paper for the Katzenbach Committee
Entitled "Coordination and Policy Approval of Covert
Operations"

1. Inadvertently we neglected to indicate in paragraph 2 (on page 7) of subject paper that NSC-5906/1 entitled "Basic National Security Policy" (which we incorrectly referred to as "[REDACTED] Security Policy"):

a. Was actually approved on 5 August 1959 and reaffirmed on 10 November 1960; and

b. Was rescinded on 17 January 1963.

2. The NSC rescission memorandum states (that) "For the present, current policy guidance is to be found in existing major policy statements of the President and Cabinet officers, both classified and unclassified." (sic)

3. In paragraph 4 (page 3) of subject paper (where we described the 4 March 1963 internal CIA directive setting forth the criterion for submission) it will be noted that [REDACTED] are mentioned.

4. I relayed the above correction/addition to Mr. Rosenthal of the Katzenbach Committee on 1 March 1967 by telephone.

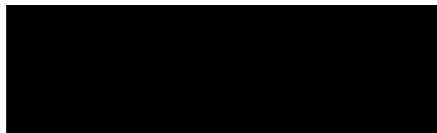
