Dear Dr. Glennan:

Pursuant to action of the United States Intelligence Board (USIB) we are forwarding the National Intelligence Estimates (NIEs) and Special National Intelligence Estimates (SNIEs) indicated in the attached list. Because of the interest which your representatives had indicated in estimates dealing with subjects such as guided missiles, space vehicles, atomic energy, and over-all Soviet military and scientific policies and capabilities, the Board believed that these papers would be of particular interest.

As we have indicated previously, National Intelligence Estimates are treated as sensitive documents and given special security handling regardless of the classification of the particular estimate. Moreover, this group of estimates includes papers of unusual sensitivity, certain of which have highly classified annexes. For that reason, certain of the estimates and annexes will be sent to you through different channels including the following: SNIE 11-9A-59; NIE 11-2-60; Annex C to NIE 11-5-60; and Annex to NIE 100-4-60.

Our understanding, as before, is that your office is in a position to meet all technical security requirements for the storage and handling of materials bearing the classification of these estimates. We also understand that these papers will be made available only to appropriately cleared personnel with a need-to-know.

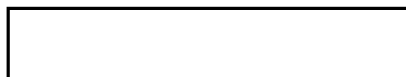

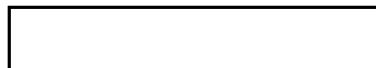

SUBJECT: Release of Estimates to NASA

1. The United States Intelligence Board has authorized the release of certain NIE's and SNIE's to the National Aeronautics and Space Administration (NASA). Since your office normally handles the storage and distribution of documents bearing the classification of certain of these estimates, it is requested that you forward the following material to Dr. T. Keith Glennan, Administrator, NASA, 1520 "H" Street, N. W., Washington, D. C.:

- a. SNIE 11-9A-59.
- b. NIE 11-2-60.
- c. Annex to NIE 100-4-60.

2.
