FERRED TO IN THE ACCOMPANYING NOTE WILL NOT BE APPLIED TO CANADIAN VESSELS AT THIS TIME. APPROPRIATE AUTHORITIES OF THE UNITED STATES ARE PREPARED TO DISCUSS THIS MATTER WITH THE APPROPRIATE AUTHORITIES OF THE GOVERNMENT OF CANADA. THE SECRETARY OF STATE WOULD BE GRATEFUL IF THE AMBASSADOR OF CANADA WOULD FORWARD THIS INFORMATION TO HIS GOVERNMENT IN CONJUNCTION WITH THE ACCOMPANYING NOTE.
