2. Although unclassified, these photographs are not of course intended for general public distribution.

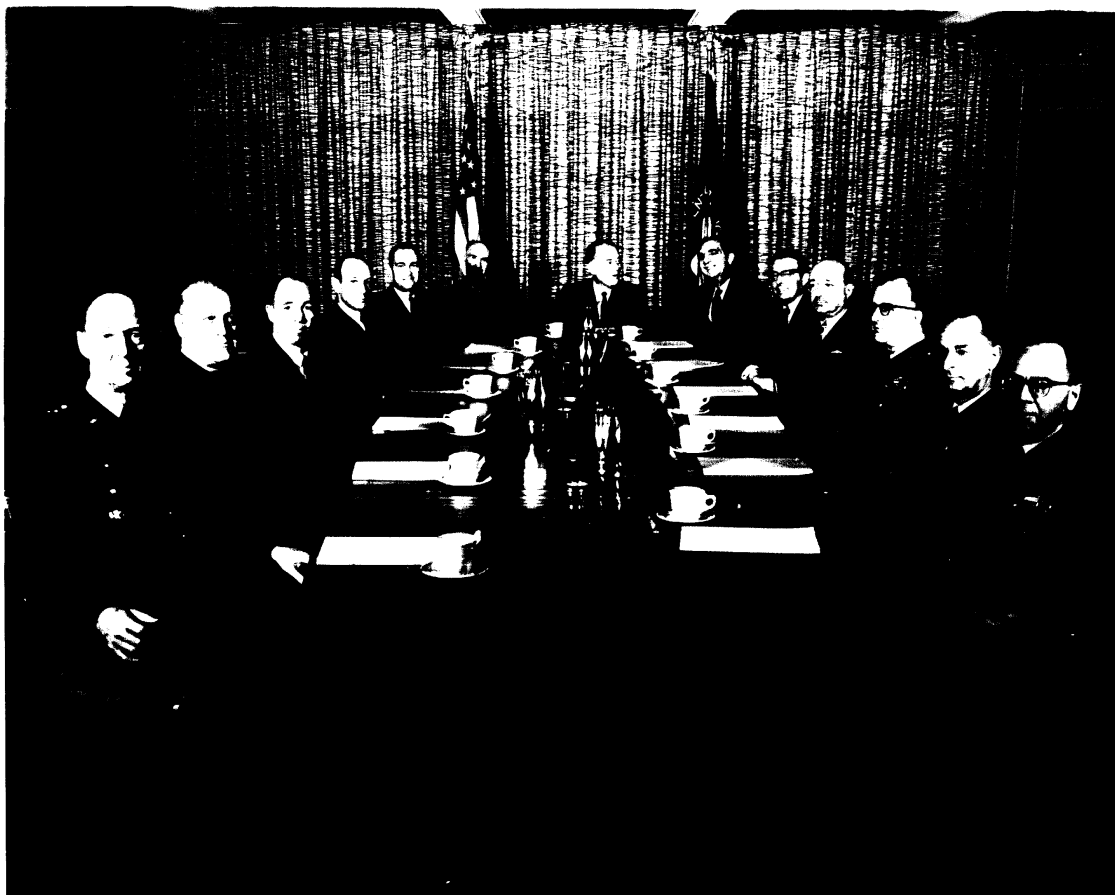
3. Attention is also invited to the fact that the specific functions and subjects dealt with by the USIB are classified matters. 25X1A
