Now I am, within a narrow range, able to work and I will be very happy to send you reprints very soon. Hoping for a deep cooperation in our sphere of work between us."

- 3. My original suspicions as to the relaxation of regulations preventing Orbit scientists from corresponding with foreign colleagues seems confirmed. Further, it is significant that a man of Csinady's stature in physiology is allowed to work after 10 years of being denied the opportunity. I am looking forward to receiving reprints from Dr Csinady in the near future.
