MEMORANDUM FOR: Director of Personnel

SUBJECT : Administrative Authorities of Director, FBIS

1. This memorandum contains in paragraph 4 a request for your approval.

2. A memorandum from the Office of General Counsel dated 5 January advised the Director, FBIS that with the exception of wage administration, he "does not appear to have sufficient legal authority at the present time to generally proceed independently of CIA channels and procedures" with respect to the administration of FBIS alien employees.

3. The OGC memorandum recommends that steps be taken to secure for the Director, FBIS "new delegations or independent authority by regulation" in this area.

4. Therefore I request that you redelegate to the Director, FBIS the authority to implement in accordance with existing regulations the following actions for FBIS alien employees:

- a. appointment, termination (within the 3-year probationary period), direction and general administration;
- b. payment of allowances;
- c. downgradings, demotions and other disciplinary actions;
- d. promotions, PSI's, QSI's and other merit awards,
- e. employee complaints and grievances (with right of appeal to DCI).

5. I would appreciate your prompt consideration and action on this request.
