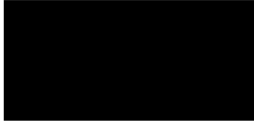

By reference A Headquarters concurred in the conclusion and recommendations of SFPAC, reference B, for the development of logistic support requirements and in the general concept of wartime employment of [REDACTED] as a basis for further planning and stated that certain logistics planning data, essential to the preparation of [REDACTED] war plans, would be provided. A copy of [REDACTED] emergency plan was furnished by reference C. Based on a re-evaluation of the [REDACTED] emergency plan, as requested by reference D, the attached study on evacuation and logistics requirements was prepared by [REDACTED] and is forwarded herewith for your information and use.

2. Headquarters has reviewed reference B and concurs generally in the original concepts and planning actions as stated therein. However, in view of the elapsed time since the preparation of these concepts, certain modifications, as a result of the currently existing situation and possible changes in SFPAC's and/or CENPAC's concept of the wartime employment and support of KIBARK [REDACTED], may be required.

It is requested that Headquarters be advised as to the adequacy of information available to the SFPAC for the preparation of definitive war plans for KIBARK [REDACTED] and of specific actions which should be taken by Headquarters in matters of agreements and contracts which must be concluded with the appropriate military departments for the wartime employment and support of [REDACTED]. Coordination with foreign governments for the evacuation and redeployment of [REDACTED] essential to the implementation of this plan, will be

For those matters which require CNO approval as executive agent, 25X1A2g it would be helpful if CINCPAC would submit his specific recommendations along the lines of those set forth in reference B, or as mutually agreed between CINCPAC and SUPPAC.
