SUBJECT: "Documents and Conspiratorial Addresses from the Archives of the Communist Party of Italy (PCI), 1923"

1. The attached study, "Documents and Conspiratorial Addresses from the Archives of the Communist Party of Italy (PCI), 1923," is for your information and retention. It has been prepared to furnish operations personnel with the required understanding of clandestine Communist Party operations.
2. The documents upon which the report is based provide a unique insight into the workings of an illegal Communist Party apparatus. Although pertaining to an early phase of the Communist movement, they are still applicable as documentary evidence of the scope of Communist planning and conduct of secret intelligence, military and communication operations which were segregated from the overt Party mechanism.
3. We solicit any comments on the attached report, and particularly any information which may pertain to the individuals listed in Part Two of the study since this is regarded to be the preliminary phase in a series of backtrack investigations "of common concern" to all recipients.

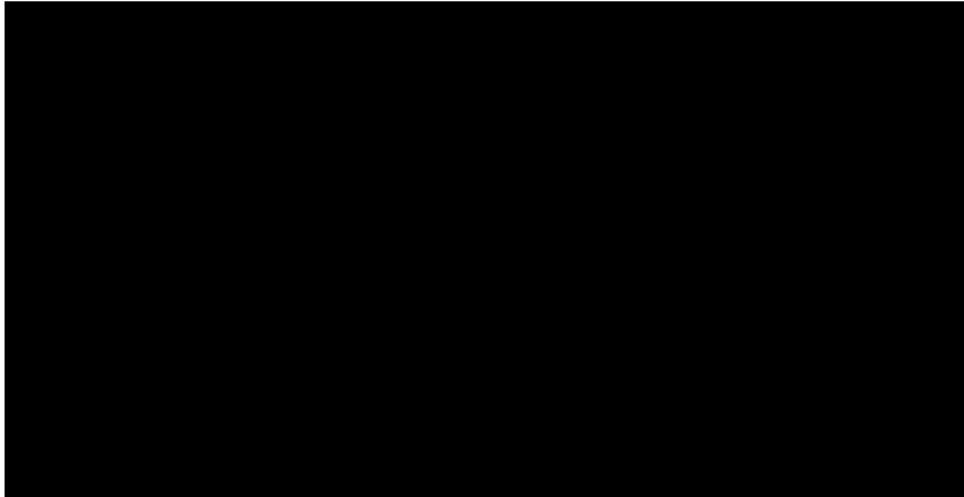
