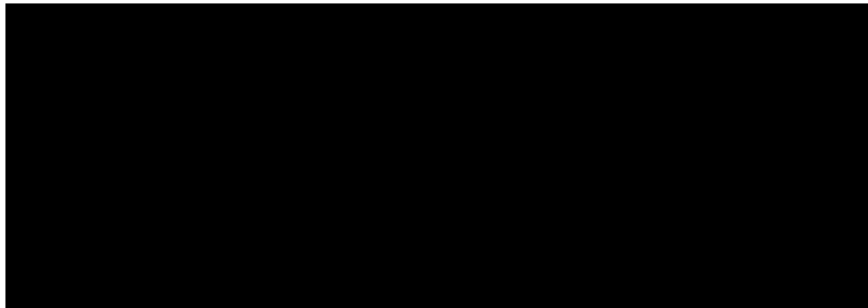
SUBJECT: Worldwide Intelligence Wrap-Up Briefing for



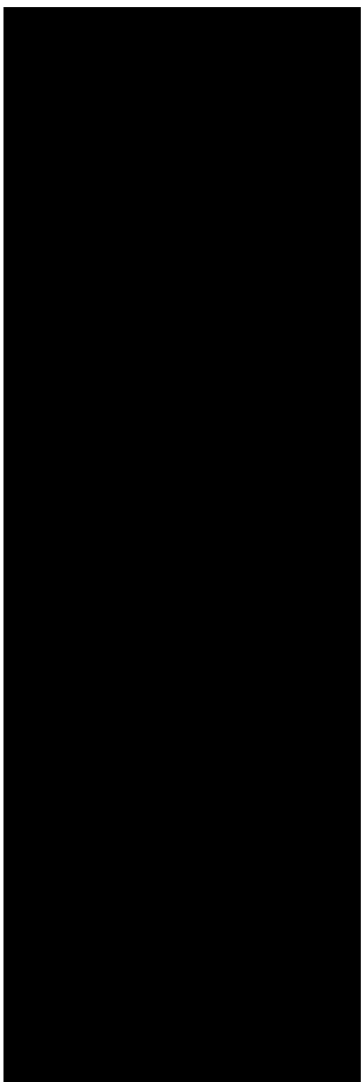
