MONTHLY HIGHLIGHTS REPORT
Special Security Center

December 1977

1. The Compartmented Information Branch, (CIB), during December deleted 893 names from the SPECLE Computer and added 1,545 names bringing the total number of names in SPECLE II to [REDACTED] at the end of December 1976. There were 1,414 cable actions and 158 briefings and debriefings conducted by CIB personnel. Nineteen hardcopy computer reports and seven micro fische were supplied to various Intelligence Community Customers during December.

2. Two Hundred Twenty-Eight (228) briefings were given to 112 CIA employees. In addition 83 briefings were presented to 32 non-CIA personnel, as follows:
