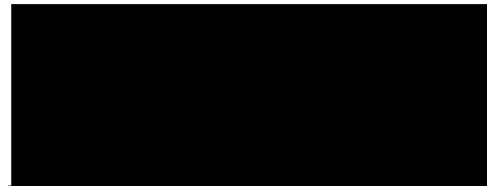

[redacted] the author of the major portion of the Office History has indicated that he sees no problem in making these volumes available, with the possible exception of those dealing with Personnel Security and Polygraph Program. We have reviewed those two volumes and find nothing in them which would preclude their circulation.

25X1A 3. [redacted] clarified the term "general circulation" to mean "Office Directors" or their "Chiefs of Plans". This being the case, I recommend that [redacted] be advised that the Office of Security has no objection to making its history available within the limits he has described.
