4. It should be noted that among those files sealed are three black notebooks entitled [redacted] briefing folders. It would appear that at one time there were five (5) copies of these briefing folders, two of which were retained by Headquarters with the remaining three maintained by the Office of Security's [redacted] Office. The two (2) Headquarters copies have been accounted for and have been sealed. However, only one of the [redacted] Office briefing folders can be accounted for, and it also has been sealed.

25X1 5. A thorough investigation to determine the disposition  
of the two missing [redacted] Office briefing folders  
has been conducted, to include interviews with appropriate  
current Office of Security employees, as well as a check of  
available file sources. It would appear probable that the  
two missing briefing folders were destroyed by the [redacted]  
[redacted] sometime following the [redacted] activity  
concerning [redacted]. Although none of those interviewed  
can specifically recall the destruction of these two folders,  
it is noted that there would have been no need to keep three  
folders containing copies of the same information (which were  
used to brief the Office of Security employees involved in the  
[redacted] had been termi-  
nated. Normal office procedures within the [redacted]  
Office at that time would have dictated that these two super-  
fluous copies be destroyed to reduce the number of files  
maintained on any one case.
