1. (U) This memorandum is for information only.
2. (U) The activities of the Office of Security during the week of 4 - 10 November 1977 were highlighted by the following items:

a. (C) During the reporting period Office of Security representatives checked and packed for shipment twenty-one alarm systems destined for [redacted]. The shipment is related to installation of a variety of residential security equipment by a security team operating in [redacted] to negate the threat occasioned by a serious crime problem in the area.
