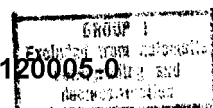

SUBJECT : Nominations For CIA Retirement Board

1. The proposed regulation for our new CIA Retirement and Disability System provides for a new CIA Retirement Board to assist and advise the Director of Personnel in the administration of the System. The regulation states that this Board "shall be composed of senior officials in appropriate numbers from the several Directorates" who shall be nominated by the respective Deputy Directors and appointed by the Director of Central Intelligence.

2. As you know, our regulation must be cleared with the Bureau of the Budget and the Chairman and ranking minority members of the House and Senate Armed Services Committees before they become effective. However, we are proceeding with the preliminary steps to expedite implementation of the System as soon as final approval of the regulations is obtained. I believe that it is particularly important to identify the members of the CIA Retirement Board so that we can begin a series of meetings with them to explain and review the legislative background of our new retirement system and the understandings which have been reached with the Committees concerning the administration of the System.

3. I would therefore appreciate receiving your nominations for members of the Board at an early date so that these can be presented to the Director of Central Intelligence for his approval.
