1. C.I.G. Directive No. 14 rescinds all previous C.I.G. directives and orders regarding the organization of the Central Intelligence Group and directs its reorganization. C.I.G. Administrative Order No. 6 establishes a tentative organization for the C.I.G., subject to revision in detail and to elaboration. The Office of Research and Evaluation, established therein, is directed to continue the operations of the former Central Reports Staff and to expand progressively toward assumption of the organization and functions indicated.

2. C.R.S. Administrative Orders Nos. 1 and 2 are hereby rescinded.

3. Pending further organizational planning and necessary recruitment, the organization of the Office of Research and Evaluation will be as follows:

a. Office of the Assistant Director for Research and Evaluation.

b. Central Reports Staff.

c. Plans and Requirements Staff.

d. Executive Staff.

e. Western Hemisphere Branch.

f. Western Europe-Africa Branch.

g. Eastern Europe - Middle East Branch

h. Far East - Pacific Branch.

4. The Central Reports Staff will direct and coordinate the activities of the regional branches in the production of strategic and national policy intelligence.

5. The immediate function of the Plans and Requirements Staff will be to accomplish the organizational planning required by paragraph 2, C.I.G. Administrative Order No. 6, in consultation with the other staffs and branches of O.R.E. It will, as soon as possible, assume the general coordination and planning functions assigned to O.R.E.

6. The Executive Staff will function as an executive office with respect to the current requirements of O.R.E., and will prepare for the earliest practicable activation of the projected Personnel and Administrative Branch, Information Center, and Intelligence Library.

7. The regional branches will carry on the current operations

of O.R.E., under coordination by the Central Reports Staff, and will prepare to assume, as soon as practicable, the additional functions indicated in C.I.G. Administrative Order No. 6. Initially, the areas of responsibility of the regional branches will be as indicated in C.R.S. Administrative Order No. 2, subject to the temporary consolidation of EE/U and IE/I.
