SUBJECT: Senior Interdepartmental Group Meeting
 on Iran

Summary of Conclusions

The Senior Interdepartmental Group (SIG) on Iran convened on July 21, Under Secretary Stoessel chairing. A draft decision memorandum (NSDD) expressing national policy toward Iran in the present or more stable circumstances was discussed. The bulk of the draft memorandum having received interagency approval at the IG level, the SIG focused on interagency differences in the portion of the draft treating arms transfer policy. These were resolved in the course of discussion. The SIG concluded in full agreement.

Action Assignments

The SIG will submit the agreed NSDD text on Iran policy to the White House for consideration by the President.
