1. In response to your request for information, it is our understanding that Mr. Bush had a 1-drawer combination lock field safe in his house at the time he was the Director of Central Intelligence. A description of the safe is attached (Attachment A). This safe is not an approved container for classified documents. It is appropriate for field use because it is portable, weighing only 110 pounds, and is equipped with handles both front and rear. It is believed that Mr. Bush had this safe to hold equipment related to his communications gear and that, in addition, he probably had an approved Class 6 2-drawer safe normally used for classified documents. A description of the Class 6 safe is contained in Attachment B. For your information, the field safe is described as follows:

Name: Field Safe 1 Drawer

Net Weight: 110 pounds

Price: \$470

Vendor: Mosler Safe Company, Hamilton, Ohio

2. Rather than providing a 1-drawer safe for Mr. Bush, it is suggested that he obtain a 2-drawer approved Class 6 container. This safe not only provides space that is more accessible but double the volume in the field type safe. The Class 6 safe is available in various colors to match office decor. The following information applies to this particular safe:
