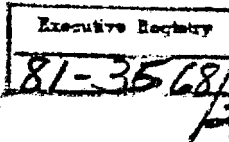

25X1 I have reviewed your letter of February 27 in which you requested an exemption for CIA from the travel reductions directed in OMB Bulletin 81-7. CIA is exempted from the reduction and, if deemed necessary, may reprogram funds in accordance with current guidelines to meet increased requirements for travel up to an overall ceiling in Object Class 21 of [redacted] excluding travel related to specific projects funded through the CIA Reserve for Contingencies. I request, however, that the savings generated from your equipment procurement reductions submitted in response to OMB Bulletin 81-9, not be used as a source of reprogramming and that other lower priority activities be identified to offset projected travel needs.
