SUBJECT: Pentagon Parking

Purpose. This circular provides updated information concerning paid parking and associated changes.

Fee Collection Deadline. Paid parking stickers for the month of November 1979 must be purchased, affixed in the upper front left corner, and properly displayed on all valid Pentagon parking permits by 0600 hours, November 1, 1979. Failure to do so will subject the driver of the vehicle to a parking violation notice and fine. Parking sticker fees may be paid at the Parking Fee Collection Office at the South end of the Concourse opposite the stage, Room 2E165, through 1630 hours, October 31, 1979.

Special Fee Window. Starting at 0800 hours, November 1, 1979 and continuing during regular Parking Fee Collection Office working hours, a special window (#5) will be open for the purpose of collecting parking fees for the month of November 1979. This window should be used to pay November 1979 parking fees only by holders of non-exempt permits issued within the month of November 1979.

Temporary Parking Area. Effective at 0600 hours, November 1, 1979, Lanes 56 and 57, North Parking are redesignated as an exempt temporary parking area for holders of valid temporary parking permits issued by the Central Parking Control Office and the Defense Component Parking Offices. Parking in this area is restricted to duty officers, personnel on temporary duty not to exceed two weeks, reserve component personnel during annual two weeks active duty, new employees up to 10 working days, and employees who are departing for other employment or another duty station prior to the 5th of the departing month.

Lost or Stolen Stickers. All permit holders who purchase monthly stickers are cautioned to safeguard these stickers particularly by locking vehicles. Valid permit holders who report lost or stolen stickers are required to purchase a new sticker.

December Fee Collection. All holders of valid Pentagon parking permits, except those specifically exempted, are responsible for paying the \$10.00 December 1979 fee in cash in accordance with the schedule on the reverse side of this circular.
