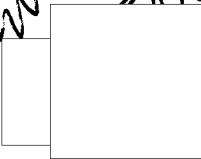

Dear Director Casey:



Because the Committee still lacks secure communications, however, I request the installation of a secure phone system at the earliest possible time. Specifics on the telephone type and location can be worked at the staff level with Susan Shekmar on 224-7206. This telephone will enhance Committee security and facilitate the timely exchange of information required during the appropriations process.
