1. Action Requested: Paragraph six of this memorandum contains a request for approval to reprogram \$96K (nonpersonal services funds) from the Guard account to the Technical Monitor Program.

2. Background: Reference B requested authorization to reprogram funds from the GSA Guard account to cover an anticipated shortfall in the budgeted amount for Confidential Correspondents (C. C. Program) and to fund the utilization of independent contractor polygraph operators. No action has been taken on this request as there was no immediate hard unfunded requirement.

There now exists an immediate hard unfunded requirement to provide funding for the "Technical Monitor" Program. This Program provides required technical supervision of contractor personnel working on the Headquarters Secure Telephone Service (HSTS) installation (Project SPEEDWIRE/FAST TRACK) and installation of Wang Alliance Systems. At the beginning of this fiscal year, there were only three monitors on board; presently there are 14, and 28 are expected to be working by the end of the fiscal year.

3. The Office of Security continues to process clearances on the HSTS contractor employees on an expedite basis and as these personnel are cleared the requirement for technical monitor support for Project SPEEDWIRE/FAST TRACK will be reduced. Unfortunately, there will be a continuing requirement for technical monitor support for the installation of Wang Alliance

Systems. It is projected that 20 man-years of technical monitor support will be utilized in FY 1983 to satisfy requirements associated with the HSTS and the Wang Alliance System installation. These requirements were not anticipated and, therefore, were not funded. The costs are being incurred now and reprogramming of \$96K from the surplus identified in Reference B (Guard account) is needed.

4. A shortfall in the C. C. Program remains a serious concern; however, current spending indicates that the underfunding may be less than the amount projected in Reference B. Additional reprogramming from the remaining surplus in the Guard account to the C. C. Program will be requested when the shortfall comes closer to reality. We will probably also require future programming actions for the technical monitors.

5. Further reprogramming of nonpersonal services funds to meet the shortfall in the Technical Monitor Program will not alleviate the FTE-other overrun caused by the Escort Program identified in Reference C. The need for approximately 30 man-years of FTE-other authorization and associated personal services funding remains valid.

6. Recommendation: That the Office of Security be authorized at this time to reprogram \$96K (nonpersonal services) from the Guard account to the Technical Monitor Program.

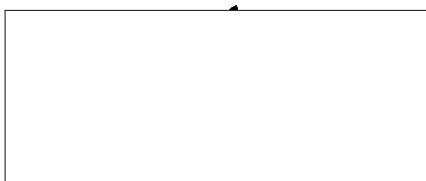
