

After nearly two years of international financial difficulties, the growth in Third World debt has slowed. Total LDC external debt increased by only 8 percent in 1983 to roughly \$700 billion, the smallest increase since the early 1970s. Behind this slowdown has been both lower LDC external financing requirements and the reluctance of commercial banks to lend to financially troubled countries. The rate of increase of total LDC debt service payments also slowed to only 6.5 percent—reaching a level of \$115 billion—largely because of extensive rescheduling of 1983 amortization payments and lower world interest rates. Even so, the aggregate LDC debt service ratio rose slightly last year as LDC export growth failed to keep pace with debt service payments. [redacted]

From an individual country standpoint, LDC debt remains highly concentrated. The 15 largest debtors owed nearly 75 percent of total LDC debt at yearend 1983. Except for Egypt and India, these countries depend heavily on private creditors, which hold about three-fourths of total LDC debt. US banks remain a major source of funds for LDCs, holding more than 35 percent of total bank claims on developing countries. [redacted]

[redacted] the growth of LDC debt this year will parallel last year's experience. If this occurs, total LDC debt should reach about \$750 billion by yearend. This in turn would mean that 1984 debt service payments will be on the order of \$120-125 billion. Unlike last year, however, interest payments will account for a larger share of total debt service because of the rise in global interest rates earlier in the year. The impact will be greatest for countries that have large amounts of floating-rate debt, such as Brazil, Mexico, and Argentina. Despite the slight expected rise in servicing requirements, the overall financing capability of the debt-troubled LDCs should improve at the margin. With economic recovery continuing in the industrial world and more realistic exchange rates in place, we believe that LDC export gains this year will result in a small increase in the ability of the LDCs to finance their debt. LDC Debt in 1983, Size and Composition

The Volume of Debt

Aggregate LDC external debt continued to increase during 1983, but the rate of growth was the lowest since the early 1970s. On the basis of international financial data, we estimate that total LDC debt¹ increased by only 8 percent, to about \$700 billion, compared with growth of 18 percent in 1981 and 11 percent in 1982. The slower growth of external debt was most noticeable among the non-OPEC LDCs. Their debt—\$585 billion at yearend 1983—increased by 7 percent, compared with 12 percent in 1982. In contrast, the eight OPEC countries lacking large asset holdings saw their debt increase at a faster pace—by 10 percent last year versus about 8 percent during 1982.

We believe the major reason behind the slowdown in overall LDC debt growth remained the reluctance of creditors—primarily commercial banks—to increase their lending in the wake of ongoing LDC economic and financial problems and lower financing requirements by LDCs which had undertaken stiff austerity measures. Although both of these causes are highly interrelated, numerous financial sources indicate that, in most cases, new bank lending to financially troubled LDCs was done involuntarily in conjunction with IMF-supported adjustment programs.


Service Payments

Scheduled debt service payments for the LDCs in 1983 totaled about \$115 billion,² up 6.5 percent from 1982. This total includes roughly \$20 billion in arrearages, as well as about \$40 billion in new principal and some \$55 billion in new interest charges. If arrearages are excluded, LDC debt service payments were only about \$95 billion, the first-ever drop in these payments by LDCs. A review of financial

statistics indicates that the slower growth of scheduled LDC debt service payments was largely explained by the increase in rescheduled debt, a drop in world interest rates, and to a lesser extent by the decline in new bank lending.

Although the growth of debt service payments slowed, the aggregate LDC debt service ratio³ inched up from

25 percent in 1982 to 27 percent in 1983 as LDC exports of goods and services increased at an even slower pace. In contrast to the overall debt service ratio, the interest portion of total LDC debt service showed a small decline—from 60 percent in 1982 to 52 percent last year. Interest payments last year, therefore, equaled 14 percent of LDC total exports of goods and services, down from 15 percent in 1982. The importance of this ratio is that interest payments are considered essential for LDCs to maintain minimum credit standing with banks, whereas principal repayments can be rolled over or delayed.

Composition of Debt

Private creditors—mainly commercial banks—continued to be the most important source of funds for LDCs. For the third straight year, private creditors accounted for nearly two-thirds of total medium- and long-term debt. If short-term debt is included, private creditors account for almost three-fourths of total LDC debt.


US banks remain a major source of funds for LDCs. US bank claims on LDCs totaled \$121 billion at end of June 1983,⁴ which represented more than 35 percent of total bank claims on LDCs, as reported by the Bank for International Settlements (BIS). Latin America accounted for about \$83 billion in US bank claims, followed by East Asia⁵ with \$28 billion. Among individual countries, the largest debtors to US banks at end of June 1983 were Mexico, Brazil, Venezuela, and South Korea (table 1).

With the exception of UK banks, debt data for non-US bank creditors are unavailable. UK bank claims on LDCs were about \$50 billion in mid-1983, or about 15 percent of total BIS bank claims on LDCs. More than \$28 billion of this total was accounted for by Latin American debtors. Mexico, Brazil, and Argentina were the three largest debtors to UK banks.

Distribution of Debt

LDC external debt continued to be concentrated in a small number of countries in 1983. The 15 largest LDC debtors (table 2) accounted for nearly 75 percent of total LDC debt last year. Except for Egypt and India, all of these countries depended heavily on private sources of financing. From a regional standpoint, distribution of debt remained heavily weighted toward Latin America in 1983, accounting for just over half of total LDC debt. East Asia had the next highest concentration of LDC debt with 21 percent of the total, while the rest of the Third World accounted for the remaining one-fourth of LDC debt.

Outlook for 1984

Discussions with financial experts and a review of financial publications suggest that LDC debt in 1984 will grow at roughly last year's pace. If this occurs, LDC external debt will reach about \$750 billion by yearend. Based on current patterns, private creditors—primarily commercial banks—will account for more than half of the increase, with governments and multilateral institutions providing the rest.

increased their loan exposure to large debtors by 20 percent per year in the past, will increase their exposure by only 7 to 8 percent—about the same rate as in 1983.

If these trends materialize, LDC debt service payments will be on the order of \$120-125 billion in 1984, slightly higher than in 1983. Unlike last year, however, interest payments will account for a greater share of the total because of the rise in global interest rates and also the reduced share of principal repayments resulting from continued reschedulings. Despite the slight increase in servicing requirements, the overall position of the LDCs should improve at the margin. Given the pace of Western economic recovery and the more realistic level of LDC exchange rates, we believe increased LDC exports in 1984 probably will bring about a slight reduction in the overall LDC debt service ratio.

This, of course, is not to say that the LDCs have turned the corner on the debt front. Even under optimistic circumstances, the LDCs at best are stabilizing an already fragile situation. Even without a further rise in world interest rates, a major shutoff in

LDC Debt: A Regional View

Private sources held 87 percent of Latin American debt last year, with US banks providing about 26 percent of the private total. The aggregate debt service ratio for Latin America was 53 percent in 1983, nearly double the overall LDC average of 27 percent. In addition, the aggregate debt-to-exports ratio^a of 298 percent for Latin America greatly exceeded the LDC average of 161 percent.

More than 74 percent of East Asian debt in 1983 was held by private sources, and US banks held about one-fourth of this. The group's 1983 debt service ratio was the lowest of any region—13 percent—as was the debt-to-exports ratio of 84 percent. These figures were part of the reason that lenders regarded East Asia—except for the Philippines—as the only creditworthy region among the LDCs during 1983.

In North Africa, the Middle East, and South Asia, private sources supplied only 41 percent of total debt, with US banks accounting for about 11 percent of the 1983 private total. These countries' aggregate debt service and debt-to-exports ratios—18 percent and 124 percent, respectively—were both below the LDC average.

Private creditors held 54 percent of Sub-Saharan Africa's total debt in 1983; however, only about 12 percent of the debt to private sources was owed to US banks. Two countries—Nigeria and the Ivory Coast—together accounted for nearly half of the region's debt from private sources but only about 9 percent of Sub-Saharan's total official debt. If these two countries are excluded, official sources accounted for more than 60 percent of Sub-Saharan African debt. The group's debt service ratio of 29 percent and debt-to-exports ratio of 177 percent were each slightly above the LDC average.

Appendix A

Methodology

Sources of Data

The primary data sources used for our debt and debt service estimates are the World Debt Tables (WDT), published by the International Bank for Reconstruction and Development (IBRD); the International Financial Statistics (IFS), published by the International Monetary Fund (IMF); and the Maturity Distribution of International Bank Lending, published by the Bank for International Settlements (BIS). The WDT provides information up to 1982 on medium- and long-term official and officially guaranteed debt and debt service positions for 103 countries. It compiles all medium- and long-term debt of governments and official agencies as well as private-sector debt that is guaranteed by an official agency in the debtor country. The WDT also supplies estimates on private nonguaranteed debt and debt service for 19 countries.

The IFS publishes information on foreign bank assets—broken down into interbank loans and loans to nonbanks—in developing countries and foreign non-bank deposits in LDC banks. The data come from the banking authorities in the G-10⁶ countries, Austria, Bahrain, Denmark, Hong Kong, Ireland, Singapore, and Switzerland, and information provided by the monetary authorities of more than 100 developing countries. Most of the information is current to yearend 1983.

The semiannual BIS publication⁷ provides information on external assets of commercial banks located in the G-10 countries, Switzerland, Austria, Denmark, Ireland, and certain foreign affiliates, with the most recent data being the positions at the end of June 1983. External assets include bank loans and other debt instruments held by reporting banks, such as bonds. The assets are broken down into debt maturing

in one year or less, debt maturing in more than one and up to two years, and debt maturing in over two years.

Another important source of data is the *External Debt of Developing Countries*, published by the OECD. The OECD provides medium- and long-term debt and debt service estimates of both official and private nonguaranteed debt up to 1982. Its compilers attempt to include all medium- and long-term debt on an individual country basis. In addition, the OECD covers all developing countries. Other data sources we have used include debt and debt service information published in country studies by the IMF, debt estimates made by LDC governments, embassy estimates, [redacted] and open-source reports.

Estimating Medium- and Long-Term Debt

For most countries we estimated medium- and long-term debt from WDT, IFS, and BIS data. Data on debt from official sources were taken from the WDT. The base for debt from private sources was derived by taking WDT data on disbursed debt owed to financial markets and comparing it with medium- and long-term debt estimates derived from IFS and BIS data.

To obtain IFS/BIS estimates of medium- and long-term debt held by foreign banks, we subtracted BIS assets maturing within one year from total assets, and then added the prior year's assets maturing within one to two years. We then compared total BIS assets with IFS foreign bank assets located in developing countries. If the IFS total exceeded the BIS number, we multiplied the IFS number by the ratio of the BIS medium- and long-term estimate to total BIS assets.

If the IFS or BIS estimate on medium- and long-term debt exceeded the WDT debt owed to financial markets, it was used instead of the WDT figure.

When the WDT had data on nonguaranteed debt, the IFS or BIS medium- and long-term estimate was compared to the WDT total debt—including private nonguaranteed—owed to financial markets. In cases where the IFS or BIS estimate exceeded the WDT estimate, that estimate again was used in place of the WDT figure. [redacted]

To obtain 1983 debt estimates, we projected the WDT 1982 estimates and the end of June 1983 BIS data to yearend 1983 and then followed the same procedure. Although the WDT does not have 1983 individual country estimates, it does publish aggregate estimates under three country groupings: major LDC borrowers, low-income African countries, and all other LDCs. These aggregates are divided between debt owed to official and private sources. To obtain specific country base estimates on official and officially guaranteed debt for 1983, we multiplied the 1982 WDT debt totals for each LDC by 1 plus the percentage change from 1982 to 1983 of the WDT aggregate debt estimates. [redacted]

To obtain yearend 1983 BIS estimates on medium- and long-term debt owed to banks, we multiplied the BIS end of June 1983 semiannual data by 1 plus the percentage change in total bank assets from the end of June to the end of December 1983 of the BIS quarterly report on the external positions of banks. [redacted]

We also used OECD data to form a base estimate for countries that do not report their debt to the IBRD, or in instances where we believed a large portion of nonguaranteed debt was not caught by the WDT, the IFS, or the BIS. [redacted]

Once the base estimates on medium- and long-term debt were made, we used other information to adjust the estimates. For example, IMF external debt and debt service estimates were a key source of information for adjusting the base estimates, especially for 1983. We also used 1983 debt estimates published by the IBRD when available. In addition, we used embassy [redacted] along with LDC government and open-source reports to adjust the base estimates. [redacted]

Estimating Short-Term Debt

For most countries, we estimated short-term debt by first subtracting our BIS medium- and long-term debt estimates from total BIS assets. When the IFS debt held by foreign banks exceeded the BIS number, we multiplied the IFS total by the ratio of the BIS short-term estimate to total BIS assets. We then added the short-term estimate derived from the BIS or IFS to the IFS data on nonbank deposits in developing country banks to get a base estimate. IMF short-term debt estimates, [redacted] and open-source data were used when available. We did not make short-term debt estimates with BIS or IFS data for countries where major offshore banking activities were present because of the inability to separate loans used by the host country and loans involved in the offshore banking facilities. The offshore centers for which short-term debt estimates were not made were The Bahamas, Bahrain, Barbados, Hong Kong, Lebanon, Liberia, Panama, and Singapore. [redacted]

Quality of Debt Statistics

In our judgment, these debt estimates can be viewed as minimum levels. For many countries, there are substantial data gaps, especially in the area of short-term debt and private nonguaranteed debt. For example, our short-term debt estimates generally cover debt held by banks and nonbank deposits in LDC banks but exclude nonbank trade-related credits. For the larger debtors such as Brazil and Argentina, however, estimates available from IMF and debtor country sources included some of this short-term nonbank trade-related debt. Moreover, recent data published by the OECD and the BIS capture some of the nonbank trade-related debt; further details on these data are found in appendix B. [redacted]

Appendix B

Incorporating Nonbank Trade-Related Credits Into the Debt Estimates

The OECD and the BIS are now jointly publishing data on nonbank trade-related credits to LDCs on a semiannual basis. We have incorporated this source of data—*Statistics on External Indebtedness: Bank and Trade-Related Nonbank External Claims on Individual Borrowing Countries and Territories*—into a separate series of debt estimates for 1982 and 1983.

The new data allow us to capture more than \$30 billion in additional debt. We did not incorporate these data into our regular series of debt and debt service estimates—which are found in appendix D—because the new data only cover yearend 1982 and end of June 1983 and would cause a discontinuity in the growth of LDC debt between 1981 and 1982.

Moreover, the new information does not contain any debt service estimates for the additional debt captured. We believe, however, that the debt estimates included in this appendix are more representative of the actual level of outstanding debt.

The new data on nonbank trade-related debt include credits that are under official insurance or guarantees and officially financed export credits from the exporting country. Part of these data—medium- and long-term suppliers' credits and officially financed export credits—are included in the World Bank debt estimates. To avoid double counting, we subtracted 1982 medium- and long-term suppliers' credits as reported by the World Bank from the BIS-OECD data. To avoid double counting of officially financed export credits, we took the aggregate 1982 OECD estimate of the proportion of export credits to LDCs that are officially financed and subtracted that from the BIS-OECD data. We assumed that the bulk of the remaining credits are short term, and we added these to the debt estimates from appendix D. To estimate yearend 1983 nonbank trade-related debt, we multiplied our 1982 estimates by 1 plus the change in BIS-OECD debt from December 1982 to June 1983. We then added this to our 1983 estimates in appendix D.


Interest Cost and Composition of LDC Debt

The external debt of developing countries is composed of different types of loans that vary with respect to interest cost and availability for different borrowers. Bilateral and multilateral Official Development Assistance (ODA) loans are the least expensive form of credit. The OECD estimates that the average interest cost on outstanding ODA loans is roughly 2 percent. ODA currently accounts for roughly 20 percent of total medium- and long-term LDC debt; however, the distribution is concentrated in the poorer developing countries that generally are unable to attract the more expensive commercial bank credits.

The average interest costs on outstanding medium- and long-term export credits, multilateral nonconcessional loans, and bonds is about 8 to 9 percent, according to OECD estimates. The bulk of these credits are on fixed-interest terms. Export credits currently account for about 20 percent of total medium- and long-term debt. These credits are composed of direct official financing, supplier credits, and subsidized or guaranteed credits financed by commercial banks. We estimate that roughly a third of all export credits are bank financed. Bonds and non-concessional multilateral lending currently account for about 2 and 8 percent, respectively, of total medium- and long-term debt. The bulk of these outstanding debt instruments are on fixed-interest terms.

In addition to export credits, commercial bank lending to developing countries generally takes the form of financial credits and short-term credits. Medium-term financial credits are the most expensive form of debt to LDCs because most of these are based on floating-interest rates such as LIBOR or US prime. The OECD estimates that the average interest cost of floating rate debt was 12.7 percent in 1983. Financial credits currently account for some 39 percent of total medium- and long-term LDC debt with most of these credits concentrated in the high-income developing countries. Short-term credits include loans with an original maturity of less than one year along with outstanding lines of credit.

The currency composition of LDC debt varies widely from one type of credit to another. Although information on the currency composition is limited, the OECD estimates that 56 percent of medium- and long-term debt is denominated in US dollars. The OECD also indicates that about 90 percent of medium- and long-term bank loans—excluding export credits—are in US dollars. On the other hand, only 30 percent of export credits are denominated in US dollars. The OECD also estimates that some 80 percent of short-term debt is in US dollars.
