SUBJECT : Implementing Procedures Required by the
National Environmental Policy Act of 1969

1. This memorandum contains a recommendation for your approval; such recommendation is contained in paragraph 5.

2. The referent memorandum recommended that the Director of Logistics be designated as the responsible official for preparation of environmental impact statements as specified in the National Environmental Policy Act of 1969 (NEPA). That memorandum also requested your approval of both a proposed Logistics Instruction (LI) and a Headquarters Notice (HN) intended to fulfill procedural requirements of the NEPA. The recommended actions were approved on 2 March 1972, subject to minor revision and streamlining of the proposed HN. Subsequent to that approval, this Office has been in contact with the Council on Environmental Quality (CEQ) to obtain their comments on the proposed LI. This coordination is required by the NEPA and was outlined in the referent memorandum.

3. The above coordination has now been achieved (Attachment 1) and the comments of the CEQ have been incorporated into paragraphs 4 and 5 of the revised LI (Attachment 2). Also, at the request of the Advisory Council on Historic Preservation (Attachment 3), paragraph 3d(1)(a) of the LI has been enlarged to specifically include historic, archaeological, architectural, and cultural resources as environmental amenities to be considered in preparing environmental impact statements. Finally, the HN has also been revised and is attached for your approval (Attachment 4).

4. Subsequent to issuance, a copy of the LI will be forwarded to the CEQ and to the Environmental Protection Agency (EPA). You should be aware that this LI will, in effect, become a "public document." The CEQ will make the LI available to the public and publish it in the Federal Register.

5. In view of the time elapsed since approval of the referent memorandum and the revisions cited above, it is requested that you again approve the attached HN, as well as issuance of the attached LI and its submission to the CEQ and EPA.
