We have reviewed the four speeches you sent us. Two are unclassified and thus releasable in their entirety. (These are the Ocean Reef and Commonwealth Club speeches). The other two, however, require some deletions. The Old Crows speech contains classified material from page 31 on. Only the first 30 pages may therefore be released. The untitled speech, incorrectly marked "Baltimore Council," was originally written for DCI use with selected Pages nine and ten are classified and cannot be released.


