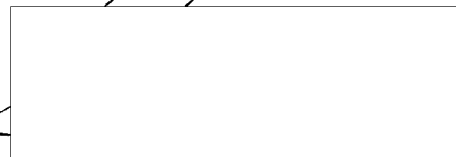
Many thanks for your letter of October 19 about Bill Rowell's arms control verification draft.



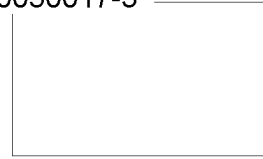
