There are 6 attachments; namely, #1 Technical Surveillance Countermeasures; #2 Computer Security; #3 Intelligence Information Compartmentation; #4 Research & Development; #5 Personnel Security; and #6 Unauthorized Disclosures Investigations. It is SECOM's operating style to establish subcommittees to work out details under the scope of these 6 areas to prevent the full Committee from being staffed out positions. In this sense the details of generic areas of security become "the Charter" of a subcommittee. The subcommittee therefore is a creature of the SECOM and not of DCID 1/11.</p>
