The first volume entitled, "DEA Oversight and Budget Authorization" reviews the activities, programs, and fiscal year 1985 budget of the Drug Enforcement Administration.

The second volume is entitled "FBI Oversight and Budget Authorization" and reviews the accomplishments and events affecting the Bureau during the preceding year. In addition, this volume records the discussion between the Subcommittee and the FBI pursuant to forecasting needs and requirements for the upcoming year.
