Invitation to Address the Kansas City Press Club and Sigma

Delta Chi Journalistic Fraternity

- 1. Action Requested: Accept or decline an invitation to address the Kansas City Press Club and the professional journalists' fraternity Sigma Delta Chi at a fund-raising dinner in May or early June in Kansas City, Missouri.
- 2. Background: Columnist Ray Morgan of the KANSAS CITY TIMES (on behalf of the Kansas City Press Club and the Sigma Delta Chi fraternity) has invited you to be the principal speaker at a fund-raising dinner honoring the fraternity's 75th anniversary. You have been asked to make 30 minutes of remarks without questions and answers. (See opposite for Morgan's biography.) The proceeds from the dinner go toward scholarships for area journalism schools. You could expect an audience of approximately 500 made up of members of the press club, the fraternity, area civic leaders, and faculty members from the University of Missouri and the University of Kansas School of Journalism.
- ° Mr. Morgan claims to have contacted you several times when you were a board member of Capital Cities Communications, Inc. Moreover, he states that he attended a reception at the Metropolitan Club given in your honor by Dr. Gordon Hoxie of the Center for the Study of the Presidency shortly after you became DCI. Morgan notes in his letter to you that Capital Cities Communications provided funds for a book on the Freedom of Information Act to be distributed to college and university libraries.
