

Attached is a proposed Executive order (E.O.) entitled "Responsibilities of the Federal Departments and Agencies for National Security Emergency Preparedness" (Attachment A). The proposal would amend E.O. 11490, "Assigning Preparedness Functions to Federal Departments and Agencies," dated October 30, 1969.

The September 15, 1986, transmittal from John H. Carley, General Counsel, the Office of Management and Budget (OMB), to General Counsels of Federal Departments and Agencies (Attachment B), outlines how the proposed order was developed and changes from the previous 1984 version of the draft order. Attachment C is a line-in/line-out version which indicates changes from the previous 1984 version of the proposed order. The OMB has requested formal comments on the proposed order by October 6, 1986. Any comments you may have on the proposed order should be submitted through your Agency's General Counsel to OMB. In addition, we would be pleased if you would share your comments with us. PART 1 - PREAMBLE

Section 101. National Security Emergency Preparedness Policy. The policy of the United States is to have sufficient capabilities at all levels of government to meet essential defense and civilian needs during any national security emergency. A national security emergency is any occurrence, including natural, technological, or other emergency, which seriously degrades or seriously threatens the national security of the United States. Policy for national security emergency preparedness shall be established through the National Security Council. All national security emergency preparedness activities shall be consistent with the goal of preservation of our Constitutional government.

- Sec. 102. Scope. (1) This Order addresses all national security emergency preparedness functions and activities, including planning and operational activities of the Federal departments and agencies, which complement national defense readiness planning and operational capabilities. These functions and activities provide the foundation for the United States Government to respond in mobilizing essential resources to meet a national security emergency.
- (2) This Order does not apply to natural, technological, or other emergencies, unless such situations constitute a national security emergency.
- (3) This Order does not apply to routine emergencies to which response is normally the responsibility of individuals, the private sector, volunteer organizations, local and/or State governments, and/or specified Federal departments and agencies acting pursuant to their own statutory or other authorities.

- (4) The Department of Defense and other agencies are exempt from provisions of this Order that pertain to providing information on, or evaluation of, military policies, plans, programs, or states of military readiness.
- (5) National security emergency preparedness telecommunications functions and responsibilities are not assigned by this Order. All such functions are otherwise assigned by Executive Order.
- (6) National security emergency preparedness assignments shall be based, wherever possible, on extensions of the regular missions of the Executive agencies.
 - Sec. 103. Management of National Security Emergency Preparedness.
- (1) The National Security Council is the principal forum for consideration of national security emergency preparedness policy. The Assistant to the President for National Security Affairs, in consultation with members of the National Security Council, is responsible for developing, coordinating, and insuring implementation of national security emergency preparedness policy approved by the President.
- (2) The Assistant to the President for National Security Affairs is responsible for oversight of the Federal government's national security emergency preparedness programs.
- (3) National security emergency preparedness functions shall be managed by the Federal department or agency having primary responsibility, and shall be supported by other departments and agencies having related responsibilities.

- (4) All Federal departments and agencies shall be prepared to respond effectively to any national security emergency, including those situations for which no formal plans or procedures have been established. Federal departments and agencies shall develop plans, provide guidance, train, equip, exercise, evaluate, and be prepared to implement their emergency management capabilities. Such capabilities shall be adequate to respond to all national security emergencies, including those that are international or national in scope, and those that may occur within any region of the Nation. National security emergency preparedness planning will assure decentralized capabilities whenever feasible.
- (5) All Federal departments and agencies will consider national security emergency preparedness factors in the conduct of their regular functions, particularly those functions essential in time of emergency. Emergency plans, programs, and an appropriate state of readiness, including organizational infrastructure, shall be developed as an integral part of the continuing activities of each Federal department and agency having the responsibility for carrying out such plans and programs during any national security emergency.
- (6) The Director of the Federal Emergency Management Agency shall serve as an advisor on issues of emergency preparedness, mobilization preparedness, civil defense, continuity of government, natural and technological disasters, and other issues, as appropriate.
- (7) The Director of the Federal Emergency Management Agency shall assist in the implementation of national security emergency preparedness policy through a coordinating role with the other Federal departments and agencies and with State and local governments; provide periodic reports

to the National Security Council on implementation of national security emergency preparedness policy; and provide staff support as requested by the National Security Council.

- (8) All Federal departments and agencies shall provide appropriate data and information to the National Security Council for the purpose of monitoring implementation of national security emergency preparedness policy.
- (9) All Federal departments and agencies will conduct and/or participate, as appropriate, in national security emergency preparedness exercises designed to demonstrate their emergency management capabilities.
- Sec. 104. Relationship Between National Security Emergency Preparedness and Domestic Policy. All appropriate Cabinet members and agency heads shall be consulted regarding national security emergency preparedness policy issues having major domestic policy implications. Likewise, the National Security Council and all other appropriate Cabinet members and agency heads shall be consulted concerning domestic policy issues relating to national security emergency preparedness.

PART 2 - GENERAL PROVISIONS

- Sec. 201. General. Each Federal department and agency, as appropriate and to the extent necessary to fulfill its responsibilities for national security emergency preparedness, shall:
- Design preparedness measures to permit a rapid and effective (1)transition from routine to emergency operations, and to make effective use of the period following initial indication of a probable national security emergency. This will include:
- (a) Development of a system of emergency actions that defines alternatives, processes, and issues to be considered during various stages of national security emergencies.
- Identification of low-cost actions that can be taken in peacetime or during the early stages of a crisis to reduce significantly the lead times associated with full emergency action implementation.
- Design plans and procedures to retain maximum flexibility for (2)the President in the implementation of emergency actions.
- Establish the management infrastructure needed to implement (3)national security emergency preparedness plans.
- Base national security emergency preparedness measures on the use of existing organizations, resources, and systems to the maximum extent practicable.
- Make recommendations to the National Security Council for establishment and implementation of policies for, and coordination and evaluation of, national security emergency preparedness activities and functions of the Federal government. DRAFT

- (6) Coordinate with Federal departments and agencies, State and local government offices, and other organizations. Relations with appropriate segments of the private sector shall be maintained to foster mutual understanding of Federal national security emergency plans.
- (7) Assist in developing State and local plans for providing essential services, and develop national plans to support State and local plans.
- (8) Assure that plans consider the consequences of funding disruptions upon State and local government and private sector-provided essential services.
- (9) Appoint a senior policy official as Emergency Coordinator, responsible for developing and maintaining a multi-year emergency preparedness plan for the department or agency to include objectives, programs, and budgetary requirements.
- (10) Identify and correct regulations and other legal constraints which unreasonably delay or otherwise interfere with effective emergency management.
- (11) Cooperate in compiling, evaluating, and exchanging relevant data related to all aspects of national security emergency preparedness.
- (12) Develop dynamic governmental and public information programs for both routine and emergency conditions.

- (13) Provide emergency information concerning Acts of Congress, presidential proclamations, Executive orders, regulations, and notices of actions to the Archivist, National Archives and Records Administration, for publication in the Federal Register, or in the Emergency Federal Register, if established.
- (14) Develop and conduct training programs that incorporate emergency preparedness and civil defense information necessary to insure the operational effectiveness of assigned resources, systems, and facilities.
- Sec. 202. Continuity of Government. Each Federal department and agency will assure the continuity of its essential functions in any national security emergency and will take such actions as may be necessary to assure that its essential functions will be performed. These include provisions for succession to office; predelegation of emergency authority; safekeeping of essential resources, facilities, and records; establishment of emergency sites; and planning for emergency actions. These activities shall be in accordance with guidance provided by, and subject to evaluation by, the National Security Council.
- Sec. 203. Resource Management. Each Federal department and agency, as appropriate, shall:
- (1) Develop national plans to mobilize personnel, equipment, facilities, and other resources.
- (2) Evaluate the use of alternative resources to meet essential demands during and following national security emergencies.

- (3) Assess the essential emergency requirements for the production, distribution, and use of resources in their areas of responsibility, and develop options and procedures for enhancing the effective utilization of those resources, and for resolving resource deficiencies.
- (4) Participate, as appropriate, in a system of standby and voluntary agreements, to be coordinated by the Director of the Federal Emergency Management Agency, subject to the approval of the Attorney General and in consultation with the Chairman of the Federal Trade Commission.
- (5) Develop international, national, and regional plans to set priorities and allocate resources among civilian and military claimants, to the extent authorized by law. The Secretary of Defense shall review the priorities and allocations systems that are developed by other departments and agencies to meet Department of Defense needs.
- (6) Prepare plans to claim from the responsible resource agencies the materials, energy, water, minerals, land, equipment, supplies, services, and workforce needed to carry out assigned responsibilities and other essential functions, and cooperate with other agencies in developing programs to insure availability of such resources in an emergency.
- (7) Monitor the Nation's workforce needs and identify occupations and skills for which there may be a critical need in the event of a national security emergency. Develop plans and procedures for assuring the availability of such occupations and skills, including plans for avoidance of depletion of the workforce where most crucially needed and/or plans for workforce augmentation.

- (8) Develop criteria for the utilization of scarce resources in post-incident recovery from national security emergencies.
- Sec. 204. <u>Protection of Essential Resources and Facilities</u>. Each Federal department and agency, as appropriate within its substantive areas, shall:
- (1) Identify facilities and resources essential to the national defense and national welfare, assess their vulnerabilities to national security emergencies, and develop strategies, plans, and programs to minimize the loss resulting from attack or disruption during such emergencies, and to assure continued provision of essential services, including the establishment of physical security and mitigation standards for facilities and resources subject to regulatory or contractual oversight and recommendation of standards for those not so subject.
- (2) Participate in interagency activities established by the National Security Council to assess the relative importance of various facilities and resources to essential military and civilian needs to integrate response strategies and procedures.
- (3) Provide facilities protection guidance material adapted to the needs of essential facilities and services.
- (4) Maintain a capability, both at national and regional/field levels, to estimate the effects of attack on essential resources and facilities.
- (5) Encourage design and construction measures which can reduce the consequences of natural and technological (including radiation) hazards.

- Sec. 205. Federal Benefit, Insurance, and Loan Programs. The head of each Federal department and agency that administers a loan, insurance, or benefit program which relies upon the Federal government payment system shall coordinate with the Secretary of the Treasury in developing plans for the continuation or restoration of such programs in national security emergencies.
- Sec. 206. Research. The Director of the Office of Science and Technology Policy and the heads of Federal departments and agencies having significant research and development programs shall advise the National Security Council of scientific and technological developments that should be considered in national security emergency preparedness planning.
- Sec. 207. Redelegation. The head of each Federal department and agency is hereby authorized, to the extent permitted by law, to redelegate the functions assigned by this Order, and to authorize successive redelegations to organizations, officers or employees within that department or agency.
- Sec. 208: Transfer of Functions. Recommendations for transfer of any emergency preparedness function assigned under this Order or for assignment of any new emergency preparedness function shall be coordinated with all affected Federal departments and agencies before submission to the National Security Council.
- Retention of Existing Authority. Nothing in this Order shall be deemed to derogate from assignments of functions to any Federal department or agency or officer thereof made by statute, Executive Order, or Presidential directive or memorandum. DRAFT

PART 3 - DEPARTMENT OF AGRICULTURE

- Sec. 301. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Agriculture shall:
- (1) Develop plans to provide adequate and continuing production, processing, storage, and distribution of essential food resources in national security emergencies, and to provide for the domestic distribution of seed, feed, fertilizer, and farm equipment, with priority distribution to the normal wholesale level.
- (2) Plan to provide agricultural products to meet international responsibilities in national security emergencies.
- (3) Develop plans and procedures for administration and use of Commodity Credit Corporation inventories of food resources in national security emergencies.
- (4) Develop plans and direct activities for the use of resources under the jurisdiction of the Secretary of Agriculture and, in cooperation with the Departments of Commerce, Defense, and Interior, the Tennessee Valley Authority, and other government entities, plan for the national security emergency operation, production, and processing of forest products.
- (5) Develop, under the guidance of the Secretary of Defense, plans and programs for water to be used in agricultural production and food processing in national security emergencies.
- (6) Prepare, in cooperation with Federal, State, and local agencies, plans and programs to prevent and control fires in rural areas of the United States.

- (7) Develop plans to provide the Nation's farmers with production resources, including national security emergency financing capabilities.
- (8) Develop plans, consistent with those of the Department of Health and Human Services and the Environmental Protection Agency, for national security emergency agricultural health services and forestry, including:
- (a) Diagnosis and control or eradication of diseases, pests, or agents of biological or chemical warfare against animals, crops, timber, or products thereof;
- (b) Protection, treatment, and handling of livestock and poultry, or products thereof, which have been exposed to or affected by hazardous agents;
- (c) Use and handling of crops, agricultural commodities, and timber which have been exposed to or affected by hazardous agents; and
- (d) Assuring the safety and wholesomeness, and minimizing losses from hazards, of animals and animal products and agricultural commodities and products under continuous inspection by the Department of Agriculture or owned by the Commodity Credit Corporation or by the Department of Agriculture.
- Sec. 302. <u>Support Responsibilities</u>. The Secretary of Agriculture shall:
- (1) Assist the Federal Emergency Management Agency in formulating and carrying out plans for stockpiling strategic and critical agricultural materials, including assessment of national and international requirements for food and fiber in national security emergencies.

August 1, 1986

- (2) Assist the Departments of Health and Human Services, Interior, and Treasury, and State governments, with repatriation of United States citizens evacuated from foreign countries to the Continental United States.
- (3) Assist the Secretary of the Treasury in preparedness activities intended to reduce susceptibility to manipulated economic pressures.

August 1, 1986

PART 4 - DEPARTMENT OF COMMERCE

- Sec. 401. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Commerce shall:
- (1) Develop control systems for priorities, allocation, production, and distribution of materials and other resources made available under such systems for national defense and essential civilian programs and the construction and operation of facilities assigned to them.
- (2) Develop procedures by which new production facility construction proposals will be reviewed for appropriate location in light of such factors as security and the availability of labor, water, power, housing, and other support requirements.
- (3) Identify those industrial products which are essential to mobilization readiness, national defense, or post-attack survival and recovery; conduct comprehensive vertical integration studies for industrial impact on readiness objectives; and identify the facilities capable of producing such products and evaluate the importance of such facilities to the national security.
- (4) Analyze potential effects of national security emergencies on actual production capability, taking into account the entire production complex, including shortages of resources, and recommend preparedness measures that would strengthen capabilities for production in emergencies.

- (5) Develop plans, in conjunction with the Secretary of the Treasury, for providing emergency assistance to essential business establishments through direct or participation loans for the financing of production facilities and equipment.
- (6) Prepare for the regulation and control of exports and imports under the jurisdiction of the Department of Commerce, as required in national security emergencies.
- (7) Provide for the collection and reporting of census information on the status of human and economic resources, including population, housing, agriculture, manufacture, mineral industries, business, transportation, foreign trade, construction, and governments, as required for national security emergency planning purposes.
- (8) Plan, create, and maintain a capability for the conduct of emergency surveys to provide information on the status of populations national security emergency preparedness plans and programs of the Federal government.
- (9) Develop overall plans and programs to ensure that the fishing industry continues to produce essential protein in national security emergencies.
- Sec. 402. <u>Support Responsibilities</u>. The Secretary of Commerce shall:
- (1) Assist the Federal Emergency Management Agency in formulating and carrying out plans for stockpiling strategic and critical materials for industrial production, construction, and distribution.

August 1, 1986

- (2) Cooperate in developing machine tool trigger orders and, based upon defense and energy requirements, determine which orders to activate.
- (3) Provide meteorological, hydrologic, and marine weather data and information to Federal, State and local agencies, as appropriate.
- (4) Provide current and forecast meteorological information about wind speed and direction, low level stability, precipitation and other meteorological and hydrologic factors affecting the transport or dispersion of radioactive and other hazardous materials and make this information available to Federal, State, and local authorities for public dissemination, as appropriate.
- (5) Provide geodetic, hydrographic, climatic, seismic, and oceanographic data and services to Federal, State, and local agencies, as appropriate.

PART 5 - DEPARTMENT OF DEFENSE

- Sec. 501. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Defense shall:
 - (1) Provide the military response to national security emergencies.
- (2) Develop, with industry, reliable capabilities for the rapid increase of defense production.
- (3) Develop and maintain national security emergency plans, programs, and mechanisms to ensure:
- (a) Efficient management of military support to Federal, State, and local governments, in cooperation with the Attorney General and the Director of the Federal Emergency Management Agency; and
- (b) Effective mutual support between the military, civil government, and private sector, in cooperation with the Director of the Federal Emergency Management Agency and the heads of other Federal departments and agencies.
- (4) Develop and operate damage assessment systems and assist the Federal Emergency Management Agency and other departments and agencies in their responsibilities as stated in Section 204(3).
- (5) Arrange, through agreements with the heads of other Federal departments and agencies, for transfer of certain Federal and civilian resources to the jurisdiction and/or operational control of the Department of Defense in national security emergencies.
- (6) Develop overall plans for the management, control, allocation, and use of the water resources of the Nation, in cooperation with the Federal departments and agencies having statutory or delegated water responsibilities. This includes:

- (a) Coordination of national security emergency water resource planning at the regional, State, and local levels;
- (b) Developing plans and maintaining river control operations for the prevention and control of floods affecting water resources under the jurisdiction of the Secretary of the Army;
- (c) Developing plans for national security emergency assistance to public water supply utilities; and
- (d) Developing plans to assure continued operation of waterways and harbors.
- (7) Manage all emergency planning and response activities pertaining to Department of Defense nuclear facilities including offsite coordination.
- (8) Assist the Secretary of Labor in determining and planning how best to mobilize the Nation's scientific and engineering workforce for national security emergencies. Seek information from the Director of the National Science Foundation concerning the Nation's scientific and engineering workforce.
- (9) Coordinate with the Administrator of the National Aeronautics and Space Administration on development and maintenance of technologically advanced systems, equipment, and methodologies.
 - Sec. 502. Support Responsibilities. The Secretary of Defense shall:
- (1) Advise and assist the Director of the Federal Emergency Management Agency, the Secretary of Commerce, and the heads of other Federal departments and agencies in the development of plans and programs to support military mobilization. This includes providing, as appropriate:

- (a) Military requirements, prioritized and time-phased to the extent possible, for selected end-items and supporting services, materials, and components; and
- (b) Recommendations for use of financial incentives and other powers under Title III of the Defense Production Act of 1950, as amended.
- (2) Advise and assist other Federal departments and agencies in the development of national security emergency manpower policies including information relating to the size and composition of the Armed Forces and military and civilian personnel force levels.
- (3) Advise and assist other Federal departments and agencies in planning for the protection of or evacuation and repatriation of United States citizens in threatened areas overseas.

PART 6 - DEPARTMENT OF EDUCATION

- Sec. 601. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Education shall:
- (1) Develop plans for the earliest possible resumption of educational systems following national security emergencies. This includes assistance to educators and educational institutions to locate and use surviving facilities, equipment, books, and educational personnel.
- (2) Provide national leadership and coordination in conducting education and training to meet shortages of critical skills and educational specialties.
- (3) Identify and assess changes to educational systems which may occur in national security emergencies.
- (4) Provide assistance to local educational agencies for national security emergency related costs.
- (5) Develop plans for dissemination of emergency preparedness (self-help) information through educational institutions and the media during national security emergencies.
 - Sec. 602. Support Responsibilities. The Secretary of Education shall:

PART 7 - DEPARTMENT OF ENERGY

- Sec. 701. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Energy shall:
- (1) Conduct national security emergency planning and administer operational programs for fuel and power, including those of the Electric Power Marketing Administration, the Federal Energy Regulatory Commission, the Strategic Petroleum Reserve, and the Naval Petroleum and Oil Shale Reserves, including:
- (a) Providing information, in cooperation with Federal and State officials, on energy supply and demand conditions and on the availability of critical materials in the energy supply system; and
- (b) Developing, in consultation with the energy industry, the necessary plans, programs, and procedures to discharge these responsibilities.
- (2) Identify energy facilities essential to the mobilization, deployment, and sustainment of resources to support the national defense and national welfare, and develop strategies to ensure continued provision of minimum essential services in national security emergencies.
 - (3) Ensure continuity of production of nuclear weapons.
- (4) Provide guidance and oversight for all national security emergency planning activities pertaining to Department of Energy nuclear materials facilities.
- (5) Assure the security of nuclear materials, nuclear weapons or devices, and all other Department of Energy programs.

August 1, 1986

(6) Participate, as required, in search, recovery, and deactivation operations for nuclear materials, weapons or devices.

Sec. 702. Support Responsibilities. The Secretary of Energy shall:

- (1) Provide such advice and resources as can be made available to assist Federal, State, and local officials in protecting the public health and safety and minimizing property and environmental damage.
- (2) Consult with the Director of the Federal Emergency Management
 Agency in energy national security emergency planning and in the development
 of energy resource management procedures and regulations.

August 1, 1986

PART 8 - DEPARTMENT OF HEALTH AND HUMAN SERVICES

Sec. 801. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Health and Human Services shall:

- (1) Promote the development of State and local plans for the provision of health services in national security emergencies, and develop appropriate plans to support such State and local plans.
- (2) Develop national plans to mobilize the health industry and health resources for national security emergencies.
- (3) Develop national plans to set priorities and allocate health resources among civilian and military claimants.
- (4) Develop health and medical survival information programs for individuals and groups, to be used in the event that professional emergency health services are unavailable for extended periods, and develop and require, to the extent permitted by law, a nationwide program to train health professionals and paraprofessionals in special knowledge and skills which would be useful in national security emergencies.
- (5) Develop programs to reduce or eliminate adverse health effects produced by biological, chemical, or radiological agents.
- (6) Develop guidelines which will assure reasonable and prudent standards of purity and/or safety in the manufacture and distribution of food, drugs, biological products, medical devices, food additives, and radiological products in national security emergencies.

- (7) Prepare national plans for assisting States in rehabilitation of persons injured or disabled by national security emergencies.
- (8) Develop plans and procedures to assist State and local governments in the provision of emergency human services, including lodging, feeding, clothing, registration and inquiry, social services, and family reunification.
- (9) Develop, in coordination with the Department of Education, human services educational and training materials including self-help program materials for use with human service organizations and professional schools; also, develop and distribute civil defense information relative to emergency human services to the States, voluntary agencies, and professional groups.
- (10) Develop plans and procedures for assistance to noncombatant United States citizens or dependents evacuated from overseas areas.
 - (11) Develop plans for national security emergency:
- (a) Payment of health insurance claims for Medicare and Medicaid eligible recipients;
- (b) Financial assistance to human services institutions and/or individuals; and
 - (c) Continuation or restoration of the Social Security program.
- Sec. 802. <u>Support Responsibilities</u>. The Secretary of Health and Human Services shall:
- (1) Assist the Chairman of the Railroad Retirement Board in developing plans for continuation of benefit payments during national security emergencies.

PART 9 - DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

- Sec. 901. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Housing and Urban Development shall:
- (1) Develop plans for construction and management of housing in national security emergencies, including:
- (a) Providing temporary housing using Federal financing arrangements for repair and restoration of damaged housing; construction and management of housing units; use of tents, inflatable structures, recreational vehicles, and manufactured housing; and conversion of non-residential structures to residential use.
- (b) Providing for shelter by encouraging construction of shelters and use of low-cost design and construction techniques to maximize population protection.
- (2) Develop plans, in cooperation with the Director of the Environmental Protection Agency, to restore community facilities including water and waste disposal facilities, damaged in national security emergencies.
- Sec. 902. <u>Support Responsibilities</u>. The Secretary of Housing and Urban Development shall:

PART 10 - DEPARTMENT OF THE INTERIOR

- Sec. 1001. <u>Lead Responsibilities</u>. In addition to the responsibilities covered in Parts 1 and 2, the Secretary of the Interior shall:
- (1) Develop programs and encourage the exploration, development, and mining of strategic and critical and other nonfuel minerals for national security emergency purposes.
- (2) Provide guidance to mining industries in the development of plans and programs to insure continuity of production during national security emergencies.
- (3) Develop, under the guidance of the Secretary of Defense, plans and programs relative to water and water resources under the jurisdiction of the Secretary of the Interior.
- (4) Plan for the management, control, allocation, and use of land of the Nation in national security emergencies and coordinate land emergency planning at the Federal, State, and local levels.
- Sec. 1002. <u>Support Responsibilities</u>. The Secretary of the Interior shall:
- (1) Assist the Federal Emergency Management Agency in formulating and carrying out plans for stockpiling strategic and critical minerals.
- (2) Cooperate with the Department of Commerce in the identification and evaluation of essential facilities.

August 1, 1986

PART 11 - DEPARTMENT OF JUSTICE

- Sec. 1101. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Attorney General shall:
- (1) Coordinate all Federal government law enforcement activities, including Federal law enforcement liaison with State and local governments.
- (2) Coordinate domestic planning for national security emergency law enforcement contingencies which are beyond the capabilities of local officials and agencies, to ensure that all agencies provide adequate support.
- (3) Manage the Federal government's law enforcement response to all domestic terrorist incidents, except for those aircraft hijackings under the exclusive authority of the Federal Aviation Administration.
- (4) Develop plans for national security emergencies for the control of aliens within the United States and, in consultation with the Secretaries of State, Treasury, Health and Human Services, and Defense, develop plans for the control of persons attempting to enter or leave the United States.
- (5) Develop plans, in consultation with the Secretaries of State and Treasury, for the seizure and administration of property of enemy aliens during national security emergencies, under provisions of the Trading With The Enemy Act, as amended.
- (6) Develop plans and procedures for the administration of laws governing the import, manufacture, and distribution of narcotics, and render all possible aid and assistance in the control of Government stockpiles of narcotic drugs, during national security emergencies.

August 1, 1986

- (7) Develop, in consonance with national civil defense programs, a program for instruction and training for law enforcement officers, and assist the States in preparing for the conduct of intrastate and interstate law enforcement operations to meet extraordinary needs for police services.
- (8) Develop plans and procedures for the custody and protection of prisoners and the use of available Federal penal and correctional institutional resources for mass feeding and housing during national security emergencies, in cooperation with local authorities, and advise States and their political subdivisions regarding the use of State and local prisons, jails, and prisoners during such emergencies.
- (9) Develop procedures for assisting Federal, State and local authorities in identifying fatalities and reuniting families in national security emergencies.
- (10) Maintain liaison with Federal courts and with the Congress to ensure mutual understanding of Federal plans involving law enforcement and the exercise of legal powers during national security emergencies.
- (11) Develop plans for the continuity of essential law enforcement, legal advice, judicial, and correctional Federal government functions during national security emergencies.
 - Sec. 1102. <u>Support Responsibilities</u>. The Attorney General shall:
- (1) Review and provide legal advice regarding emergency directives, procedures, extraordinary measures, and voluntary agreements prepared by Federal departments and agencies for use in national security emergencies.

August 1, 1986

- (2) Develop plans for providing legal advice and document review for the President, the Cabinet, and the heads of Executive departments and agencies in national security emergencies.
- (3) Assist the private sector, local and State governments, and other Federal departments and agencies in the development of national asset protection plans.

PART 12 - DEPARTMENT OF LABOR

- Sec. 1201. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Labor shall:
- (1) Develop plans and issue guidance designed to use civilian workforce resources effectively. Such plans shall include, but not necessarily be limited to:
- (a) Priorities and allocations, recruitment, referral, training, employment stabilization (including appeals procedures), use assessment, and determination of critical skill categories;
- (b) Methods for determining critical skill and occupation categories for use in recruitment, based on essential military and civilian production priorities; and
- (c) Programs for increasing the availability of critical workforce skills and occupations in high demand.
- (2) Develop plans and procedures for wage, salary, and benefit costs stabilization, and for assisting operating stabilization agencies.
- (3) Develop plans and procedures for wage and salary administration and death and disability compensation for authorized civil defense workers and, as appropriate, measures for unemployment payments, re-employment rights, occupational safety and health, and other protections and incentives for the civilian labor force during national security emergencies.
- (4) Develop, in consultation with other appropriate government agencies and private entities, plans and procedures for effective labor-management relations during national security emergencies.
 - Sec. 1202. Support Responsibilities. The Secretary of Labor shall:

PART 13 - DEPARTMENT OF STATE

- Sec. 1301. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of State shall:
- (1) Provide overall foreign policy direction, coordination, and supervision to other Federal departments and agencies in the formulation and execution of continuity of government and national security emergency preparedness activities that have foreign policy implications, affect foreign relations, or depend, directly or indirectly, on the policies and capabilities of the Department of State.
- (2) Prepare to carry out Department of State responsibilities in the conduct of the foreign relations of the United States during national security emergencies, under direction of the President, including, but not limited to:
- (a) Formulation and implementation of foreign policy and, in consultation with other appropriate Federal agencies, negotiation of contingency and post-emergency plans, intergovernmental agreements, and arrangements with our allies;
- (b) Formulation, negotiation, and execution of policy affecting the relationships of the United States with neutral States;
- (c) Formulation and execution of political strategy toward hostile or enemy States;
- (d) Formulation and execution of economic measures with respect to other nations, in consultation, as appropriate, with the Secretaries of Commerce, Defense, and Treasury;
 - (e) Conduct of mutual assistance activities;

August 1, 1986

- (f) Providing foreign assistance, including continuous supervision and general direction of authorized economic and military assistance programs;
- (g) Protection or evacuation of United States citizens and nationals abroad and safeguarding their property, in consultation with the Secretaries of Defense and Health and Human Services;
- (h) Protection of international organization and foreign diplomatic, consular, and other official personnel and property, or other assets, in the United States; and
- (i) Formulation of policies and provisions for assistance to displaced persons and refugees abroad.
 - Sec. 1302. Support Responsibilities. The Secretary of State shall:
- (1) Develop planning assumptions concerning accessibility of foreign sources of supply.

PART 14 - DEPARTMENT OF TRANSPORTATION

- Sec. 1401. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of Transportation shall:
- (1) Develop and promulgate overall national policies, plans, programs, procedures, and systems to meet essential civil and military transportation needs in national security emergencies.
- (2) Be prepared to direct all modes of civil transportation in national security emergencies, including air, surface, water, pipelines, and public storage and warehousing, to the extent such responsibility is vested in the Secretary of Transportation by law. This direction may include:
- (a) Implementation of priorities for all transportation resource requirements for service, equipment, facilities, and systems; and
 - (b) Allocation of transportation resource capacity.
- (3) Develop and furnish military requirements for selected end items and related logistics areas required for Coast Guard support of the Department of Defense.
- (4) Participate in and provide for United States transportation representation to international civil emergency preparedness planning and related activities.
- (5) Cooperate with State and local highway agencies in the management of all Federal, State, city, local and other highways, roads, streets, bridges, tunnels, and publicly-owned highway maintenance equipment during national security emergencies.

- Sec. 1402. <u>Support Responsibilities</u>. The Secretary of Transportation shall:
- (1) Develop plans and procedures, in cooperation with the Department of Defense, for the involvement of the Coast Guard in collecting, compiling, and publishing information on the physical characteristics and facilities of ports of the United States and its possessions and territories.

PART 15 - DEPARTMENT OF THE TREASURY

Sec. 1501. Lead Responsibilities. In addition to the applicable responsibilities covered in Parts 1 and 2, the Secretary of the Treasury shall:

- (1) Develop plans and authorities to maintain stable economic conditions and a market economy during national security emergencies; emphasize measures to minimize inflation and disruptions; and minimize reliance on direct controls of the monetary, credit, and financial systems:
- (a) Develop plans to increase capabilities to minimize economic dislocations by carrying out appropriate fiscal, monetary, and regulatory policies and reducing susceptibility to manipulated economic pressures.
- (b) Provide the Government with efficient and equitable financing sources and payment mechanisms.
- (c) Provide fiscal authorities with adequate revenue-raising powers to meet any additional resource requirements.
- (d) Develop, in consultation with the Chairman of the Board of Governors of the Federal Reserve System, and in cooperation with the Comptroller of the Currency, the Chairmen of the Federal Deposit Insurance Corporation, the Federal Home Loan Bank Board, the National Credit Union Administration, and the Farm Credit Administration, and the Director of the Federal Emergency Management Agency, plans for the continued or resumed operation and liquidity of banks, savings and loans, credit unions, and farm credit institutions, measures for the reestablishment of evidence of assets or liabilities, and provisions for currency withdrawals and deposit insurance.

- (2) Provide for the protection of United States financial resources including currency and coin production and redemption, Federal check disbursement facilities, and precious monetary metals.
- (3) Provide for preservation of, and facilitate emergency operations of, public and private financial institution systems, and provide for their restoration during or after national security emergencies.
- (4) Provide for participation in bilateral and multilateral financial arrangements with foreign governments.
- (5) Maintain the Federal government accounting and financial reporting system.
- (6) Protect the President, the Vice President, other officers in the order of succession, and other designated persons.
- (7) Develop plans for restoration of the economy following a nuclear attack; for the development of emergency monetary, credit, and Federal benefit payment programs of those Federal departments and agencies that have responsibilities dependent on the policies or capabilities of the Department of the Treasury; and for implementation of national policy on sharing war losses.
- (8) Develop plans for initiating tax changes, waiving regulations, or, in conjunction with the Secretary of Commerce, for granting loans (including participation in or guarantees of loans) for the expansion of capacity, the development of technological processes, or the production of essential materials.

- (9) Develop plans to expand production capacity abroad for essential materials, make foreign barter arrangements, or acquire emergency imports, using, as appropriate, the resources of the Export-Import Bank, or resources available to the Bank.
- (10) Develop plans for encouraging capital inflow and discouraging the flight of capital from the United States and the impounding of securities in the hands of enemy aliens, in conjunction with the Attorney General, the Secretary of Commerce, and the Chairman of the Securities and Exchange Commission.
- (11) Regulate financial and commercial transactions within the scope of existing law, in consultation with the Attorney General and the Secretaries of Commerce and State.
- (12) Control the movement of people and materiel across the borders, in conjunction with the Secretary of Commerce and the Attorney General.
- Sec. 1502. Support Responsibilities. The Secretary of the Treasury shall:
- (1) Cooperate with the Attorney General on law enforcement activities which may cause or occur during national security emergencies.
- (2) Cooperate and consult with the Chairman of the Commodity Futures Trading Commission with regard to trading of commodity futures and options contracts, maintenance and restoration of stable and orderly markets, protection of records of ownership and transactions, and restoration of markets and accounts in the event major trading centers are destroyed or inoperable.

(3) Cooperate and consult with the Chairman of the Securities and Exchange Commission in the development of emergency financial control plans and regulations for stock trading, while maintaining exclusive authority over temporary closure of security exchanges and protection of securities, and in the development of plans for the maintenance and restoration of stable and orderly markets for the purpose of reestablishing industry and commerce during or after national security emergencies.

August 1, 1986

PART 16 - ENVIRONMENTAL PROTECTION AGENCY

- Sec. 1601. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Administrator of the Environmental Protection Agency shall:
- (1) Develop Federal plans and foster development of State and local plans designed to prevent or minimize the ecological impact of hazardous agents introduced into the environment in national security emergencies.
- (2) Develop, in conjunction with the Secretary of Defense, plans to assure the provision of potable water supplies to meet community needs under national security emergency conditions, including claimancy for materials and equipment for community water systems.
- (3) Develop, for national security emergencies, guidance on acceptable emergency levels of nuclear radiation, assist in determining acceptable emergency levels of biological agents, and help to provide detection and identification of chemical agents.
- Sec. 1602. <u>Support Responsibilities</u>. The Administrator of the Environmental Protection Agency shall:
- (1) Assist other Federal agencies that are responsible for developing plans for the detection, reporting, assessment, protection against, and reduction of effects of hazardous agents introduced into the environment.
- (2) Consult with the Secretary of Defense on environmental protection policies that affect national security emergency preparedness.

August 1, 1986

PART 17 - FEDERAL EMERGENCY MANAGEMENT AGENCY

- Sec. 1701. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Director of the Federal Emergency Management Agency shall:
- (1) Support national security emergency preparedness planning, facilitating coordination between Federal departments and agencies and State and local governments, and assisting in the implementation of National Security Council policy through coordination among Federal departments and agencies.
- (2) Assist State and local government entities and private organizations in providing effective preparedness for national security emergencies, including development of plans and procedures for assuring continuity of government, and support planning for prompt and coordinated Federal assistance to States and localities in responding to national security emergencies.
- (3) Design, coordinate, and administer policies and programs to enhance Federal, State, and local capabilities for crisis management, population protection, and recovery in the event of an attack on the United States.
- (4) Develop, under the direction of the National Security Council, and in cooperation with appropriate Federal departments and agencies, the implementation of policies and coordination mechanisms to insure efficient mobilization of Federal, State, local, and private sector resources in response to national security emergencies.

August 1, 1986

- (5) Formulate and carry out plans for stockpiling strategic and critical materials, with the assistance of other Federal departments and agencies.
- (6) Provide the National Security Council an annual assessment of Federal, State, and local capabilities to respond to national security emergencies.
- (7) Support public education and training activities to assist Federal, State, and local government entities in planning for and implementing national security emergency preparedness programs, including radiological defense programs, and encourage volunteer activities at the community level.
- (8) Coordinate the planning and evaluation of national security emergency exercises among the Federal departments and agencies.
- (9) Assist other Federal departments and agencies in coordination of programs to ensure the continuance of industry and infrastructure functions essential to national security, to include:
- (a) Coordinated assessment of vulnerabilities to disruption and development of strategies for protection, restoration, and mitigation; and
- (b) Stimulation of business and industry to conduct all-hazard emergency preparedness planning.
- (10) Assist the National Security Council in assuring that plans are developed for continuity of the Executive Branch during national security emergencies.

August 1, 1986

- (11) Develop, with the assistance of the Secretary of Defense, capabilities to assess actual attack damage, as well as capabilities to estimate the effects of potential attacks on the Nation, in accordance with Sec. 204(3).
- (12) Provide guidance on resource-claimancy and appropriate use of Defense Production Act authorities, in order to improve the capability of industry and infrastructure systems, including transportation and energy, to meet national security emergency needs.
- Sec. 1702. Support Responsibilities. The Director of the Federal Emergency Management Agency shall:
- (1) Assist the Secretaries of Commerce and Defense, and the heads of other Federal departments and agencies, as appropriate, in preparing plans to mobilize industry in order to achieve timely and sufficient production of military and essential civilian material needed during national security emergencies.
- (a) Establish and maintain plans and mechanisms, subject to evaluation by the National Security Council, for the effective coordination of resource claimancy and voluntary allocation of resources among all Federal departments and agencies and between the Federal government and the States, at both national and regional levels, during national security emergencies. Such plans and mechanisms shall support the operations of any Federal department or agency having authority to establish priorities and allocate resources in national security emergencies.
- (b) Coordinate development and operation of a system of standby and voluntary agreements, subject to the approval of the Attorney General and in consultation with the Chairman of the Federal Trade Commission.

- (2) Assist the Secretaries of Defense and Labor and the Director of the Selective Service System, as appropriate, in developing plans and systems to ensure that the Nation's human resources are available to meet essential military and civilian needs in national security emergencies.
- (3) Assist the Secretaries of Defense, Health and Human Services, and State in the coordination and implementation of plans for the protection, evacuation, and repatriation of United States citizens in threatened areas overseas, their onward movement, and followup assistance after their arrival at their final destinations.
- (4) Coordinate and integrate, in cooperation with the Secretary of State, United States civil resources preparedness planning with allies, especially member nations of the North Atlantic Treaty Organization.
- (5) Assist Emergency Coordinators of the other Federal departments and agencies and convene, as needed, meetings of the Emergency Coordinators to address national security emergency preparedness issues.
- (6) Assist other Federal departments and agencies in enhancement and supplementation of State and local efforts to provide services for dealing with mass casualties and other mass care needs resulting from national security emergencies.

PART 18 - GENERAL SERVICES ADMINISTRATION

- Sec. 1801. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Administrator of General Services shall:
- (1) Develop national security emergency plans and procedures for the operation, maintenance, and protection of Federally owned and occupied buildings, and for the construction, alteration, and repair of such buildings.
- (2) Develop national security emergency operating procedures for the control, acquisition, leasing, assignment, and priority of occupancy of real property by the Federal government, and by State and local governments acting as agents of the Federal government.
- (3) Develop national security emergency operational plans and procedures for the use of public utility services by Federal departments and agencies.
- (4) Plan for and provide, operate, and maintain automated information processing facilities and services designed to meet the essential requirements of Federal civil departments and agencies during national security emergencies.
- (5) Develop plans and procedures for providing general transportation and traffic management services for essential activities of Federal civil departments and agencies during national security emergencies.

August 1, 1986

- (6) Prepare plans and procedures for operation of government-wide supply programs to meet the requirements of Federal departments and agencies during national security emergencies, including the development of policies, methods, and procedures for procurement and requisitioning of private property when authorized by law or other authority.
- (7) Develop plans and operating procedures for the use, in national security emergencies, of excess and surplus real and personal property by Federal, State, and local governmental entities. Review property holdings of Federal departments and agencies not having national security emergency functions to determine their availability and develop plans for the lease, loan, or disposal of real and personal property and the rehabilitation of personal property.
- (8) Promote, with respect to Federal buildings and installations, in accordance with National Security Council policy and assistance from the Director of the Federal Emergency Management Agency and the Secretary of Defense, a government-wide program to minimize the effects of attack and establish shelter management organizations, including safety and service personnel, shelter management service, first aid, police, and evacuation service.
- Sec. 1802. Support Responsibilities. The Administrator of General Services shall:
- (1) Assist the Director of the Federal Emergency Management Agency in the formulation of plans and programs relating to the certification of procurement programs, subsidy payments, the Machine Tool Trigger Order Program, and plant improvement programs provided for by the Defense Production Act of 1950, as amended.

- (2) Assist the Director of the Federal Emergency Management
 Agency in formulating plans, programs, and reports relating to the
 stockpiling of strategic and critical materials.
- (3) Provide instructions and advice on selection, maintenance, and preservation of essential records in national security emergencies, in cooperation with the Archivist, National Archives and Records Administration.

PART 19 - INTERSTATE COMMERCE COMMISSION

- Sec. 1901. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Chairman of the Interstate Commerce Commission shall:
- (1) Develop, in coordination with owners and transportation associations, plans and preparedness programs for the reduction of vulnerability, maintenance, restoration, and operation of privately owned railroads, motor carriers, inland waterway transportation systems, and public storage facilities and services in national security emergencies.
- (2) Prepare orders and regulations for the operation of domestic surface transportation and storage industries in national security emergencies.
- Sec. 1902. <u>Support Responsibilities</u>. The Chairman of the Interstate Commerce Commission shall:

PART 20 - NUCLEAR REGULATORY COMMISSION

- Sec. 2001. <u>Lead Responsibilities</u>. In addition to the applicable responsibilities covered in Parts 1 and 2, the Chairman of the Nuclear Regulatory Commission shall:

- (3) Develop plans for mortuary services for eligible veterans, and advise on methods for interment of the dead in national security emergencies involving large numbers of casualties.
- Sec. 2602. <u>Support Responsibilities</u>. The Administrator of Veterans Affairs shall:
- (1) Assist the Secretary of the Treasury and the heads of other Federal departments and agencies in the performance of insurance and loan guaranty functions in national security emergencies.



LETTER TO GENERAL COUNSELS OF FEDERAL DEPARTMENTS AND AGENCIES

Enclosed, in accordance with the provisions of Executive Order No. 11030, is a proposed Executive order, submitted by the National Security Council, entitled "Responsibilities of the Federal Departments and Agencies for National Security Emergency Preparedness."

The proposal would amend Executive Order No. 11490, "Assigning Preparedness Functions to Federal Department and Agencies," which was signed by former President Nixon on October 30, 1969. That Order is in need of updating and revision.

During the early part of this Administration, an effort was made to revise that Executive Order, and several drafts were circulated to the affected departments and agencies for review. A number of issues were resolved in that review and led to the issuance of a National Security Defense Directive on this subject.

The proposed represents a renewed effort to revise Executive Order No. 11490. It was drafted under the guidance of a Senior Interagency Group for National Security Emergency Preparedness (SIG-NSEP). The group is chaired by the National Security Council with members from the Departments of Defense, Justice, Treasury, the Office of Management and Budget and the Federal Emergency Management Agency.

The proposed order would consolidate the policy and specific jurisdictional assignments approved by Federal agencies in the previous 1984 versions of the draft order. An effort has been made to adopt a format more compatible with the order's intended role of not only assigning overall responsibilities of all Federal agencies, but also providing a reference document which clearly enumerates the important lead and support responsibilities of each agency. The proposal does not attempt to direct how an affected agency will carry out its NSEP responsibilities.

Also enclosed is a summary that describes the new structure of the order. This also includes a brief description of agency sections that have been consolidated. Copies of the 1984 draft, previously reviewed by your agency, are available from this office along with a summary of changes from that version to this version.

On behalf of the Director of the Office of Management and Budget, I would appreciate receiving any comments you may have on the proposed order. If you have any comments, they should be submitted no later than Monday, October 6, 1986.

Proposed Revision of Executive Order 11490

Executive Order (EO) 11490 is the basic order assigning responsibilities for national security emergency preparedness to the Federal departments and agencies. The current version was approved in 1969 (Tab C), and is in need of updating and revision.

Attached is a proposed revision of EO 11490 (Tab B), entitled "Responsibilities of the Federal Departments and Agencies for National Security Emergency Preparedness." I asked that the proposed revisions be coordinated with the requisite departments and agencies for comment in preparation for presentation to the President.

This draft has been developed under the auspices of the Senior Interagency Group for National Security Emergency Preparedness (SIG-NSEP) which was established by NSDD-188. A guiding principle in the drafting process was to avoid a "laundry list" of agency functions. Instead, the draft defines agency responsibilities in generic terms, requires timely attention by each agency to its essential emergency preparedness actions, and assures the major actions are mutually supportive.

I would appreciate your coordination of the interagency review of this order on an expedited basis. To assist in this endeavor we have attached a proposed letter of transmittal to the Federal departments and agencies for your use. The NSC point of contact for this matter is Norman Mingle, 395-3055. PROPOSED TRANSMITTAL MEMORANDUM

Executive Order 11490, "Assigning Preparedness Functions to Federal Department and Agencies," was signed by former President Nixon on October 30, 1969. The order is in need of updating and revision.

During the early part of this Administration, an effort was made to revise this Executive Order and it was circulated to the affected departments and agencies for review. A number of issues were resolved in that review and led to the issuance of National Security Defense Directive (NSDD) 188.

The enclosed is a renewed effort to review EO 11490. It was drafted under the guidance of a Senior Interagency Group for National Security Emergency Preparedness (SIG-NSEP). The group is chaired by the National Security Council with members from the Departments of Defense, Justice, Treasury, the Office of Management and Budget and the Federal Emergency Management Agency.

The revised EO attempts to consolidate the policy and specific jurisdictional assignments approved by federal agencies in the previous 1984 version of the draft order. An effort has been made to adopt a format more compatible with the order's intended role of not only assigning overall responsibilities of all Federal agencies but also providing a reference document by clearly enumerating the important lead and support responsibilities of each agency.

The document does not attempt to direct how the agency carries out its responsibilities.

The draft order has been written by personnel who are not experts on all the functions of your agency. We, therefore, ask for your close review of the agency-by-agency sections of the draft.

A copy of the existing (1969) EO is enclosed with the draft order for your reference. Copies of the 1984 draft, previously reviewed by your agency, are available from this office along with differences from that version to this version. Also, enclosed is a summary that describes the new structure of EO 11490. This also includes a brief description of agency sections that have been consolidated.

OVERVIEW OF DIFFERENCES BETWEEN EXTANT EO 11490 AND THE REVISED DRAFT

The redraft includes only those responsibilities which are sufficiently important to national security emergency preparedness that to be unprepared to carry them out would constitute a significant and unacceptable threat to the national security.

The reviewed document is organized as follows:

- The <u>Preamble</u> states NSEP policies and principles, defines "national security emergency," delimits coverage, and codifies the precepts of National Security Decision Directive (NSDD) 188;
- The new General Provisions outline responsibilities applicable to all federal departments and agencies, including such items as emergency coordination, continuity of government, and resource management; and
- ° The individual department/agency sections enumerate lead and support responsibilities unique to each.

In the interest of brevity, the NSEP responsibilities of certain agencies have been incorporated with those of the "primary" agency. Specifically:

- ° Functions of the Commodity Futures Trading Commission, the Export-Import Bank, the Federal Bank Supervisory Agencies, and the Securities and Exchange Commission appear in Part 15, Department of the Treasury;
- * Functions of the Federal Trade Commission, the Government Printing Office, and the Small Business Administration are covered in the General Provisions;
- ° Functions of the National Aeronautics and Space Administration relating to research and development are covered in the General Provisions; those relating to technical developments applicable to military systems/equipment appear in Part 5, Department of Defense;
- ° Functions of the National Science Foundation, which concern providing information on the Nation's scientific and engineering workforce, appear in the Department of Defense section; and
- Railroad Retirement Board responsibilities are covered in the General Provisions and in the sections on the Departments of Health and Human Services (Part 8), Transportation (Part 14), and the Treasury (Part 15).

Provisions of EO 10421, "Providing for the Physical Security of Facilities Important to the National Defense," have been incorporated into redrafted EO 11490 General Provisions, Section 204. Accordingly, we will recommend that EO 10421 be revoked.

- (7) The Director of the Federal Emergency Management Agency shall assist in the implementation of national security emergency preparedness policy through a coordinating role with the other Federal departments and agencies and with State and local governments; provide periodic reports

[PART 1 - PURPOSE AND SCOPE]

[Section 101. Purpose. This Order sets forth the assignment of emergency preparedness functions to Federal departments and agencies.]

[Sec. 102. Scope. (1) This Order is concerned with the emergency preparedness planning functions of Federal departments and agencies, which complement the national defense readiness planning responsibilities of the Departments of Defense and Energy; together, these measures provide the basic foundation for the United States' overall emergency preparedness posture. The activities undertaken by Federal departments and agencies pursuant to this Order, except as provided in Sections 206, 212, 501(31), 701(8) and 701(9), shall be in accordance with policy and planning guidance provided by, and subject to evaluation by, the Federal Emergency Management Agency, and shall be responsive to the full spectrum of potential emergencies, including domestic and national security emergencies. The Department of Defense is exempt from provisions of this Order and related documents that pertain to providing information to, or evaluation by, the Federal Emergency Management Agency with respect to military policies, plans, programs, or states of military readiness.]

- [(2) Nothing in this Order shall be deemed to constitute authority to implement the emergency plans prepared pursuant to this Order. Such plans may be implemented only under authority provided by statute or by an Order or directive issued by the President pursuant to statutes or the Constitution of the United States.]
- [(3) The functions assigned in Part 2 of this Order apply to all Federal departments and agencies listed in this Order. Additional functions assigned to particular Federal departments and agencies are described in Parts 3 through 37.]

- [(4) This Order does not assign national security or emergency preparedness telecommunications functions. All such functions, together with accompanying policy, planning and oversight responsibilities, are assigned by Executive Order No. 12472.]

Each Federal department and agency with essential functions, whether expressly identified in this Order or not, shall develop plans and take such actions, including but not limited to those specified in this Order, as may be necessary to assure that it will be able to perform its essential functions. These include plans for maintaining the continuity of essential functions of the department or agency through programs concerned with:]

- [(1) Succession to office.]
- [(2) Predelegation of emergency authority.]
- [(3) Safekeeping of essential records.]
- [(4) Emergency relocation sites supported by required services.]
- [(5) Emergency action steps.]
- [(6) Alternate headquarters or command facilities.]
- [(7) Protection of government resources, facilities, and personnel.] [Continuity of government activities undertaken by Federal departments and agencies pursuant to this Order, except those for which the Department of Defense is directly responsible to the National Command Authorities, shall be in accordance with guidance provided by, and subject to evaluation by, the Federal Emergency Management Agency.]
- [Sec. 202. Preparation. Each Federal department and agency listed in this Order shall:]
- [(1) Develop preparedness programs, prepare emergency plans, and attain an appropriate state of readiness with respect to the functions assigned to the agency in this Order, in order to provide an effective capability to meet defense and civilian needs during domestic emergencies I

[and national security emergencies. Preparedness plans and programs shall be designed to respond to the following occurrences, among others: natural disasters; technological disasters, such as hazardous materials spills and nuclear power plant accidents; resource shortages; disorders, such as terrrorism and sabotage; and war. As necessary and appropriate, these preparedness plans and programs will be developed in consultation with other affected departments and agencies.]

- [(2) Give appropriate consideration to emergency preparedness factors in the conduct of the regular functions of the agency, particularly those functions essential in time of emergency.]
- [(3) Be prepared to implement the plans developed under this Order in a domestic or national security emergency.]
- [(4) Be prepared to respond effectively to any emergency, including those situations for which no formal plans or procedures have been established.]
- [Sec. 203. <u>Funding</u>. Each Federal department and agency is responsible for programming and budgeting funds and personnel to ensure the ability to carry out the responsibilities and assignments of this Order.]
- [Sec. 204. Resource Management. In consonance with the national preparedness, security, and mobilization readiness plans, programs, and operations of the Federal Emergency Management Agency under Executive Order No. 12148, as amended, and subject to the provisions of this Order, each Federal department and agency shall perform the following functions:]
- [(1) Emergency activities. Support Federal emergency mobilization and continuity of government plans, preparedness activities, emergency teams, and reconstitution efforts, in the event of an emergency.]

- (2) National Defense Executive Reserve. Establish a unit of the National Defense Executive Reserve, if deemed necessary and appropriate by the head of the appropriate department or agency, to augment executive staffing in an emergency, in accordance with the Defense Production Act of 1950, as amended, and Executive Order No. 11179, as amended.
- [(3) Priorities and allocations. Develop emergency systems for the establishment of priorities and allocations for the production, distribution, and use of resources for which the department or agency has been assigned responsibility. In particular, the Secretaries of Commerce, Defense (acting through the Secretary of the Army), Energy, Interior, and Transportation shall maintain emergency priorities and allocations systems in coordination with the Secretary of Defense for materials and equipment, water, energy, land and minerals, and transportation services, respectively. These systems shall be capable of supporting an emergency mobilization in a timely and effective manner. The Secretary of Defense shall review the priorities and allocations systems that are developed by other departments and agencies to meet Department of Defense needs, in order to determine their appropriateness and adequacy. Each affected agency shall report annually to the Federal Emergency Management Agency on the development and maintenance of systems for priorities and allocations for its respective resources.]
- [(4) Requirements. Assemble, develop, and evaluate requirements for assigned resources, taking into account estimated needs for military and civilian personnel, atomic energy, space, stockpiling, and foreign commitments. Such evaluations shall take into consideration geographical distribution of requirements under emergency conditions.]
- [(5) Evaluation. Assess assigned resources in order to estimate availability from all sources under emergency situations, analyze resource

[dations and programs, including those necessary for the maintenance of an adequate mobilization base. Provide data and assistance to the Federal Emergency Management Agency in maintaining a national resources assessment capability.]

- [(6) Resource claims. Prepare plans to claim from the responsible resource agencies the materials, energy, water, minerals, land, equipment, supplies, services, and workforce needed to carry out assigned responsibilities and other essential functions, and cooperate with other agencies in developing programs to insure availability of such resources in an emergency.]
- [Sec. 205. Facilities Protection and Warfare Effects Monitoring and Reporting. In consonance with the national preparedness, security, and mobilization readiness plans, programs, guidance and operations of the Federal Emergency Management Agency, each Federal department and agency shall perform the following functions:]
- [(1) Facilities protection. Provide facilities protection guidance material adapted to the needs of the facilities and services concerned and promote a national program to stimulate emergency preparedness and control in order to minimize the effects of natural disasters or other domestic emergencies, overt or covert attack on department or agency resources such as facilities, personnel, materials, systems and procedures. Guidance shall include, but not be limited to, organization and training of facility employees, personnel shelter, evacuation and relocation plans, records protection, continuity of management, emergency repair, dispersal of resources, and mutual aid associations for an emergency.]

- [(2) Warfare effects monitoring and reporting. Maintain a capability, both at national and field levels, to estimate the effects of attack on assigned resources and facilities and to collaborate with and provide data to the Federal Emergency Management Agency, the Department of Defense, and other agencies, as appropriate, to verify and update resource status through exchanges of data and mutual assistance.]
- [(3) Salvage and rehabilitation. Develop plans for salvage, decontamination, and rehabilitation of facilities involving assigned resources.]
- [(4) Shelter. In conformity with national shelter policy, in accordance with appropriate Presidential directives, and where authorized to engage in building construction, plan, design, and construct buildings that protect the public to the maximum extent feasible against the hazards that could result from a nuclear attack upon the United States; and where empowered to extend Federal financial assistance, encourage recipients of such financial assistance to use standards for planning design and construction which will maximize protection of the public.]
- [Sec. 206. Critical Skills and Occupations. The Secretaries of Defense, Commerce, and Labor shall monitor the Nation's workforce needs and identify any particular occupation or skill that may warrant qualifying for deferment from military service on a uniform national basis. In addition, the Secretaries of Defense, Commerce, Labor, Education, and Health and Human Services shall monitor the Nation's workforce and education needs to identify any area of graduate study that may warrant qualifying for deferment. In carrying out these functions, the Secretaries concerned shall consult with the National Science Foundation with respect to scientific workforce requirements.]
- [Sec. 207. Research. Using policies and objectives established by the Federal Emergency Management Agency, to the extent practical, each]

[Federal department and agency shall supervise or conduct research as appropriate, in areas directly concerned with carrying out its emergency preparedness responsibilities, designate representatives as necessary for ad hoc or task force groups, and provide advice and assistance to other agencies in planning for research in areas involving each agency's interest.]

Sec. 208. National Defense Stockpile. Each Federal department and agency with emergency responsibilities shall assist the Federal Emergency Management Agency in formulating and carrying out plans for stockpiling strategic and critical materials and survival items.

Each Federal department and agency shall cooperate, as appropriate, with the Federal Emergency Management Agency and the appropriate Federal financial agencies in the development of emergency preparedness programs involving both voluntary and non-voluntary financial and credit measures; price, rent, wage and salary stabilization; and consumer rationing programs.]

[Sec. 210. Financial Aid. Each Federal department and agency shall develop plans and procedures in cooperation with the appropriate Federal financial agencies for financial and credit assistance to those segments of the private sector for which that Federal department or agency is responsible in the event such assistance is needed under emergency conditions.]

[Sec. 211. International Trade. Each Federal department and agency shall cooperate, as appropriate, with the Federal Emergency Management Agency and those departments and agencies represented on the Trade Policy Committee in the development of emergency preparedness measures involving international trade and foreign exchange. To the extent feasible, these activities shall include development and application of policies during peacetime which will enhance mobilization preparedness and defense sustainability.]

The Director, Office of Science and Technology Policy shall advise the President of scientific and technological considerations involved in emergency situations in areas of national concern, including the economy, national security, health, foreign relations, and the environment; evaluate the scale, quality, and effectiveness of the Federal effort in science and technology; coordinate the research and development programs of the Government; and monitor all science, engineering, and technology resources for possible use in, and application to, all conditions of emergency.]

- [(1) National program guidance. Emergency plans, programs, and an appropriate state of readiness, including organizational readiness, shall be developed as an integral part of the continuing activities of each Federal department or agency having the responsibility for carrying out such plans and programs during an emergency. Modifications and temporary organizational changes, based on emergency conditions, shall be in accordance with policy determinations by the President.]

- [Sec. 216. Redelegation. The head of each Federal department and agency is hereby authorized, to the extent permitted by law, to redelegate the functions assigned by this Order, and to authorize successive redelegations to organizations, officers or employees within that department or agency.]
- [Sec. 217. Transfer of Functions. Recommendations for transfer of any emergency preparedness function assigned under this Order or for assignment of any new emergency preparedness function may be submitted to the President. Prior to the submission of any such recommendation, the Federal department or agency requesting such a transfer or new assignment shall consult with





This term also may involve cooperation with the Department of Agriculture in the following areas: plant and animal diseases; pest prevention, control, and eradication; wholesomeness of meat and meat products, and poultry and poultry products,]

[in establishments under continuous inspection service by the Department of Agriculture; veterinary biologicals, agricultural commodities and products owned by the Commodity Credit Corporation or the Department of Agriculture; livestock; agricultural commodities stored or harvestable on farms and ranches; and agricultural lands and water.]

- [(2) "Health workforce" means physicians (including osteopaths), dentists, registered professional nurses, health physicists, pharmacists, veterinarians, sanitary engineers, sanitarians, and members of such other occupations as may be included in the List of Health Occupations issued for the purposes of this Part by the Federal Emergency Management Agency after agreement by the Secretaries of Labor and Health and Human Services.
- [(3) "Health resources" means human resources, material, supplies, equipment, hospitals and other facilities required to prevent the impairment of, improve, and restore the physical and mental health conditions of the civilian population.]
- [(4) "Health benefits and financing" means determinations of eligibility and payments made on behalf of eligible individuals to hospitals, home health agencies, extended care facilities, physicians, and other providers of medical services under Medicare and Medicaid programs.]
- [(5) "Emergency human services" means feeding, clothing, lodging and registration of persons; locating and reuniting families; care of unaccompanied children, the aged, the handicapped, and other groups needing specialized care or services; necessary financial or other assistance; counseling and referral services to families and individuals; aid to welfare institutions; and all other feasible welfare aid and social services to people in need during an emergency.]

[(6) "Social security benefits" means the determination of entitlements and payments of benefits to persons eligible under the Social Security Act, as amended, including workers who have retired because of age or disability and their spouses and children, and eligible survivors of deceased workers; aged, blind or disabled persons eligible under the supplemental security income program, including State supplementation; and eligible families with dependent children.]

[Sec. 803. Health Functions. In consonance with emergency management plans, programs, and operations of the Federal Emergency Management Agency, the Secretary of Health and Human Services shall perform the following functions:]

Sec. [3701] 2601. [Functions.] Lead Responsibilities. In addition to applicable responsibilities covered in Parts 1 and 2, [T]the Administrator of Veterans Affairs shall: [develop policies, plans, and procedures for the performance of emergency functions with respect to the continuation or restoration of authorized programs of the Veterans Administration under all conditions of emergency, including:]

 Provide compensation, pension, rehabilitation, education, and insurance payments to eligible veterans consistent with overall Federal plans for the continuation of Federal benefit payments.

The emergency] Assist the Secretary of the Treasury and the heads of other Federal departments and agencies in the performance of insurance and loan guaranty functions in [accordance with indirect stabilization policies and controls designed to deal with] national security emergenc[y]ies [conditions].
