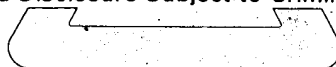

**ARMS TRANSSHIPMENT
BANGHAZI PORT FACILITIES, LIBYA**

1. (S/D) SIGNIFICANCE: SOVIET ARMS TRANSSHIPMENT IS UNDERWAY.
2. (S/D) REMARKS: A SOVIET KAPITAN KUSHNARENKO-CLASS MERSHIP WITH FISHBED AIRCRAFT CRATES ON BOARD IS AT BANGHAZI PORT FACILITIES. THIS SHIP, WHICH IS OFF-LOADING CARGO, HAS NINE FISHBED TYPE C CRATES ON DECK AND TWO POSSIBLE FISHBED COMPONENT CRATES IN THE FIFTH HOLD. A FLOATING CRANE, WITH ITS BOOM EXTENDED OVER THE CARGO HATCHES, IS MOORED ALONG THE STARBOARD SIDE OF THE SHIP. HOWEVER, NO AIRCRAFT-ASSOCIATED CRATES ARE DISCERNIBLE ON THE QUAY OR IN THE PORT AREA. A KAPITAN KUSHNARENKO-CLASS WAS PRESENT ON [REDACTED] BUT HEAVY CLOUDS PRECLUDED IDENTIFICATION OF ANY DECK CARGO.

(S/D) THE FISHBED CRATES MAY BE DESTINED FOR SOME COUNTRY OTHER THAN LIBYA. SOVIET ARMS SHIPMENTS TO LIBYA ARE NORMALLY PROCESSED AT TARABULUS PORT FACILITIES [REDACTED]. IN ADDITION, THE LIBYANS HAVE NOT PURCHASED FISHBED FOR SOME TIME, OPTING FOR THE MORE SOPHISTICATED FLOGGER AIRCRAFT.
