FOR YOUR INFORMATION:

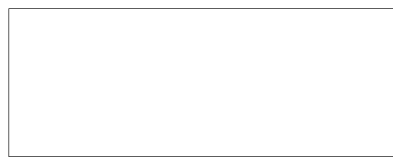
