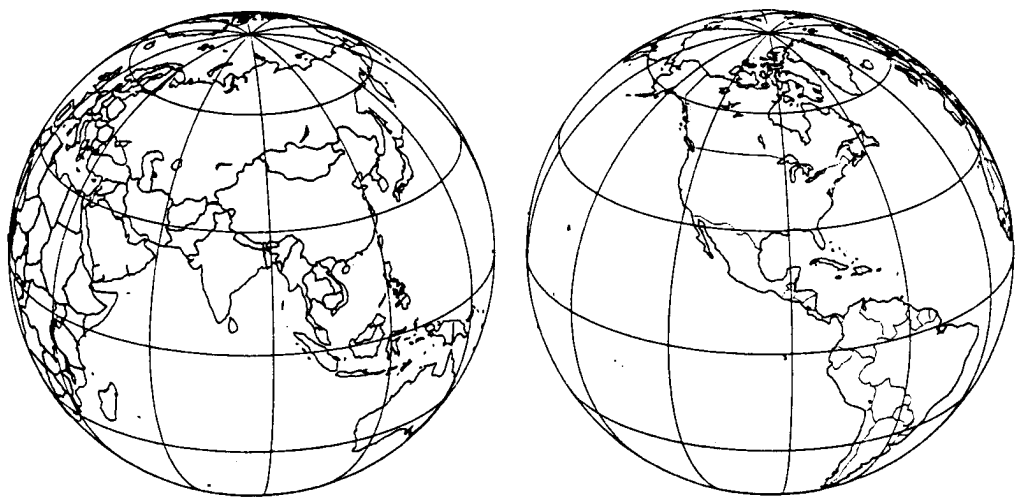

ON 28 OCTOBER 1979 IN UNITED STATES THE PRAGUE DOMESTIC NEWS SERVICE CLAIMED THAT AN UNIDENTIFIED INDIVIDUAL FIRED TWO SHOTS AT THE CAR OF A CZECH DIPLOMAT. IN THE US.

ON JULY 19, 1979 IN NICARAGUA, A US EMBASSY VEHICLE  
WAS FIRED UPON BY FSLN FORCES. ONE PERSON WAS INJURED.  
AFTER THE INCIDENT, THE LEADER OF THE FSLN FORCES APOLOGIZED  
FOR THE ATTACK AND REPRIMANDED HIS TROOPS.

ON 13 NOVEMBER 1979 IN PORTUGAL TWO GUNMEN FIRED MACHINEGUN BURSTS AND THREW A GRENADE INTO THE CAR OF ISRAEL'S AMBASSADOR IN LISBON, EPHRAIM ELGAR. HIS BODYGUARD DIED AS HE REACHED FOR HIS REVOLVER. THE AMBASSADOR SURVIVED BY STAYING IN THE CAR, BUT A BULLET BROKE A BONE IN HIS RIGHT FOREARM, ANOTHER WOUNDED HIM IN THE THIGH, AND HE SUFFERED SHRAPNEL WOUNDS. HIS DRIVER, A POLICEMAN GUARDING THE ISRAELI EMBASSY, AND A FEMALE PASSERBY WERE ALSO WOUNDED IN THE ATTACK. THE ISRAELI FOREIGN MINISTRY SAID THE DUO ESCAPED IN A CAR WHICH DISAPPEARED IN TRAFFIC. ISRAEL CLAIMED THAT THIS WAS A RESULT OF YASSIR ARAFAT'S VISIT TO LISBON TEN DAYS PREVIOUSLY AT THE ARAB SOLIDARITY MEETING. THE PALESTINE LIBERATION ORGANIZATION DENIED RESPONSIBILITY.

ON 15 DECEMBER 1979 IN CYPRUS, A TALL AND HEAVILY BUILT GUNMAN FIRED A SILENCED WEAPON AT TWO PALESTINE LIBERATION ORGANIZATION OFFICIALS WHO WERE ENTERING THEIR RENAULT WITH DIPLOMATIC PLATE JY 929, KILLING BOTH SHORTLY AFTER 6 P.M. HE RAN TO A SMALL WHITE RENTED CAR WITH ZJJ PLATES, AND DROVE OFF WITH A SECOND INDIVIDUAL. THE DEAD WERE IBRAHIM ABDUL AZIS RAGHIF, ALIAS ABU SAFWAT, 35, A MEMBER OF FATAH'S OFFICE IN BEIRUT, AND SAMIR TOUKAN, ALIAS SALIM ALI, 30, THE SECOND SECRETARY OF FATAH'S OFFICE IN CYPRUS. ALI'S WIFE, A GREEK CYPRIOT, WAS NOT HURT IN THE ATTACK.

THE PLO ACCUSED ISRAEL OF THE ATTACK. ISRAEL REPLIED THAT ABU SAFWAT WAS IN CYPRUS TO ORGANIZE RAIDS AGAINST EGYPTIAN AND ISRAELI TARGETS. THE MARJ 'UYUN LEBANON VOICE OF HOPE CLAIMED THAT LIBYA WAS BEHIND THE ASSASSINATION, IN AN ATTEMPT TO PROTECT ITS EMBASSIES FROM ATTACKS BY THE PLO, WITH WHICH IT WAS FEUDING. A NICOSIA NEWSPAPER RECEIVED A PHONE CALL FROM THE NATIONAL PATRIOTIC FRONT M.P. 14/31, WHICH SAID ''OUR INTENTION WAS TO DO IT ON THE 14TH AND NOT THE 15TH.. SAMIR HAD COLLABORATED WITH GREEK CYPRIOTS AND MAINLAND GREEKS IN CRIMES THEY HAD COMMITTED AND WERE INTENDING TO COMMIT IN THE FUTURE AGAINST THE GREEK NATION...WE WARN THOSE GREEK CYPRIOTS AND MAINLAND GREEKS WHO COLLABORATE WITH THE PALESTINIAN ORGANIZATION THAT THEY WILL SUFFER THE SAME FATE.''

POLICE ASKED INTERPOL'S AID IN FINDING JEFFREY SOWDEN, WHO RESIDES IN BRITAIN AND HOLDS A SOUTH AFRICAN PASSPORT, AND AHMAD NAJIB BURJI, WHO RESIDES IN BEIRUT AND HOLDS A LEBANESE PASSPORT.

ON AUGUST 13, 1979, IN LEBANON, AT 9 A.M., AN RPG AND MACHINEGUN FIRE WAS DIRECTED AT THE CAR OF THE IRAQI AMBASSADOR, 'ABD AL-HUSAYN HASAN, WHO WAS WOUNDED IN THE BACK AND FOOT. HIS AIDE AND DRIVER WERE ALSO WOUNDED, AND THE CAR WAS DESTROYED. HE HAD LEFT HIS HOME FOR THE EMBASSY IN THE AR-RAMLAH AL-BAYDA SECTION OF BEIRUT, AND WAS 100 METERS FROM THE EMBASSY IN THE AL-AWAZ'I AREA WHEN THE PROJECTILE WAS FIRED FROM THE AR-RUMUL AD-DAKHILIYAH AREA.

ON MARCH 25, 1980 IN NEW YORK BOMB SQUAD OFFICERS SAFELY DEFUSED A BAG OF EXPLOSIVES WHICH APPEARED TO BE A BAG OF TRASH. ABOUT 1030 HOURS ON 25 MARCH THE CHAUFFEUR/BODYGUARD OF THE CUBAN DELEGATE TO THE UN DISCOVERED THE ''TRASH'' UNDER THE DELEGATE'S CAR PARKED IN FRONT OF HIS RESIDENCE. THE BODYGUARD PUT THE BAG IN A TRASH CAN AND WENT TO CALL POLICE. A SANITATION CREW SUBSEQUENTLY TOSSED IT INTO A TRUCK FROM WHICH THE OFFICERS RETRIEVED AND DEFUSED IT WITHOUT FURTHER INCIDENT. ACCORDING TO POLICE THE PLASTIC BAG CONTAINED PLASTIQUE EXPLOSIVES.

THE ASSOCIATED PRESS RECEIVED AN ANONYMOUS TELEPHONE CALL ABOUT 1230 HOURS STATING THAT OMEGA-7 WAS RESPONSIBLE FOR PLACING OF THE EXPLOSIVES UNDER THE CAR. (OMEGA-7 IS AN ANTI-CASTRO GROUP THAT HAS CLAIMED RESPONSIBILITY FOR MANY BOMBINGS IN THE NEW YORK AREA.)

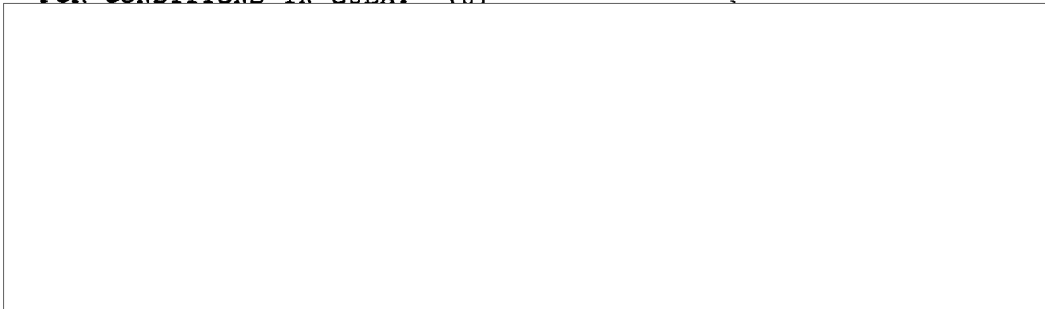
ITEM NUMBER 8920 CONTAINS DATA OF TYPE - UNCLASSIFIED

ON 11 SEPTEMBER 1980 IN NEW YORK, FELIX GARCIA RODRIGUEZ, A MEMBER OF THE CUBAN MISSION AT THE UNITED NATIONS, WAS SHOT AND KILLED EARLY ON THE EVENING OF 11 SEPTEMBER, AS HE WAITED IN HIS CAR AT A TRAFFIC LIGHT ON A HEAVILY TRAVELED BOULEVARD IN THE QUEENS AREA OF NEW YORK CITY. DESPITE THE NUMBER OF VEHICLES ON THE ROAD AT THE TIME, THE POLICE HAVE NOT BEEN ABLE TO FIND ANY EYEWITNESSES TO THE SHOOTING. THEY HAVE LOCATED FOUR PERSONS WHO WERE EITHER EAR WITNESSES OR SAW A 'COMMOTION' AT THE SCENE BUT THOUGHT IT WAS A TRAFFIC ACCIDENT. (U)

GARCIA, WHO WAS ALONE IN THE CAR HE WAS DRIVING, WAS SLAIN WITH A SINGLE BULLET THAT STRUCK THE LEFT SIDE OF HIS HEAD. THREE.45 CALIBER SHELL CASINGS WERE FOUND AT THE SCENE, LEADING THE POLICE TO BELIEVE THAT THE SHOTS HAD COME FROM A PASSING VEHICLE. THE BULLET CAME THROUGH THE OPEN WINDOW ON THE DRIVER'S SIDE. THE WEAPON IS BELIEVED TO HAVE BEEN AN AUTOMATIC PISTOL. MINUTES AFTER THE SHOOTING, AND BEFORE IT WAS ANNOUNCED BY RADIO OR TELEVISION, A CALLER TOLD UNITED PRESS INTERNATIONAL THAT OMEGA-7 COMMANDOS WERE RESPONSIBLE FOR THE 'EXECUTION', AND THREATENED THAT THE ORGANIZATION WOULD CONTINUE TO EXECUTE ALL THOSE WHO ARE RESPONSIBLE FOR CONDITIONS IN CUBA. ON 26 OCTOBER 1980 IN NEW YORK, USA, THE UKRAINIAN UN MISSION REPRESENTATIVES, WERE IN A SERIOUS AUTO ACCIDENT WHILE ENROUTE TO THE UN. A CAR BEARING FLORIDA TAGS REPEATEDLY STRUCK THE DIPLOMATS CAR UNTIL IT WAS RENDERED INOPERABLE. THE FLORIDA CAR THEN LEFT THE SCENE. NO INJURIES WERE REPORTED. THE NY POLICE AND THE FBI WERE NOTIFIED. (CONF)

ON 17 SEPTEMBER 1980 IN PARAGUAY, FORMER NICARAGUAN PRESIDENT ANASTASIO SOMOZA DEBAYLE, HIS DRIVER, AND A FINANCIAL ADVISER WERE ASSASSINATED, WHEN SOMOZA'S CAR WAS AMBUSHED WHILE THEY WERE EN ROUTE TO A BANK IN ASUNCION, PARAGUAY. SOMOZA HAD BEEN LIVING IN EXILE IN PARAGUAY SINCE HE WAS FORCED OUT OF NICARAGUA ON 17 JULY 1979. SOMOZA'S CAR WAS HIT BY A PROJECTILE FROM A ROCKET LAUNCHER, WHICH BLEW OFF THE ROOF AND KILLED ANY OCCUPANT NOT ALREADY DEAD AT A RESULT OF THE AUTOMATIC WEAPONS FIRE WHICH PRECEDED THE ROCKET ATTACK. (U)

THE AMBUSH APPEARS TO HAVE BEEN CAREFULLY PLANNED, AND IT WAS CARRIED OUT WITH PRECISE TIMING. ACCORDING TO THE PARAGUAYAN POLICE THE MEMBERS OF THE HIT TEAM WERE ARGENTINES. THE LEADER ALLEGEDLY WAS HUGO ALFREDO YRURZUN, ALIAS 'CAPTAIN SANTIAGO', A FORMER MEMBER OF THE PEOPLE'S REVOLUTIONARY ARMY (ERP) IN ARGENTINA. YRURZUN IS REPORTED TO HAVE FOUGHT WITH THE SANDINIST GUERRILLAS IN THE WAR THAT OUSTED SOMOZA. HE ARRIVED IN PARAGUAY ON 16 JULY USING AN URUGUAYAN PASSPORT. IN MID-AUGUST SILVIA MERCEDES RODGERS (NAME HAS BEEN REPORTED AS HODGERS) A COMRADE OF YRURZUN IN THE ERP, ENTERED PARAGUAY FROM BRAZIL, ALSO ON A FALSE PASSPORT. SHE RENTED A HOUSE ON AVENIDA ESPANA, HALF A MILE FROM THE HOUSE SOMOZA WAS RENTING IN TOWN, BUT CONTINUED TO STAY IN A DOWNTOWN HOTEL. THE HOUSE REMAINED EMPTY. IN EARLY SEPTEMBER A BLUE PICKUP TRUCK, WHICH WAS TO BE USED IN THE AMBUSH, WAS STOLEN IN DOWNTOWN ASUNCION. SOMOZA MEANWHILE WAS MOVING CONSPICUOUSLY ABOUT TOWN IN HIS USUAL STYLE. ALTHOUGH HE HAD BEEN WARNED BY PARAGUAYAN OFFICIALS A YEAR AGO ABOUT A POSSIBLE ASSASSINATION ATTEMPT, HE REFUSED TO ALTER HIS LIFE STYLE. SOMOZA WAS PLANNING TO LEAVE FOR HIS RANCH IN REMOTE NORTH-WEST PARAGUAY ON 18 SEPTEMBER. HIS FINANCIAL ADVISER, AN ITALIAN-BORN U.S. CITIZEN WHO LIVED IN BOGOTA, COLOMBIA, HAD ARRIVED ON 16 SEPTEMBER FOR A 12-HOUR STAY, AND SOMOZA WAS TAKING HIM TO MEET AN ASUNCION BANKER WHEN THEY WERE KILLED.

A CHRONOLOGY OF THE INCIDENT HAS BEEN DEVELOPED FROM INTERVIEWS WITH WITNESSES. AT 10:05 THE SOMOZA LIMOUSINE ROLLED OUT THROUGH THE GATES OF HIS MANSION AND HEADED ALONG AVENIDA ESPANA. THE FOUR PARAGUAYAN POLICE ASSIGNED TO GUARD HIM FOLLOWED IN ANOTHER VEHICLE ABOUT HALF A BLOCK BEHIND. AT THE SAME HOUR TWO OR THREE ARMED MEN RAN OUT OF THE HOUSE RENTED BY MISS RODGERS AT THE CORNER OF AVENIDA ESPANA AND AVENIDA AMERICA. THEY DETOURED TRAFFIC FROM THE INTERSECTION AND ORDERED THE NEIGHBORS INTO THEIR HOMES, SHOUTING THE WARNING THAT THERE WAS GOING TO BE TROUBLE AT THE SPOT. (U)

AT 10:08 THE STOLEN BLUE PICKUP TRUCK, WITH CHANGED LICENSE PLATES, WHICH HAD BEEN WAITING ON AVENIDA ESPANA A BLOCK FROM THE INTERSECTION, RACED ALONGSIDE THE LIMOUSINE AND CUT IN FRONT, FORCING SOMOZA'S DRIVER TO STOP. AT LEAST TWO OR THREE KHAKI-CLAD MEN GOT OUT OF THE PICKUP, ACCORDING TO WITNESSES, WHILE TWO OR THREE OTHERS EMERGED FROM THE RENTED HOUSE DIRECTLY OPPOSITE. FROM BOTH SIDES THEY FIRED AUTOMATIC WEAPONS INTO THE MERCEDES AND AT THE POLICE CAR BEHIND. A MAN IN THE DOORWAY OF THE HOUSE FIRED AT LEAST ONE PROJECTILE FROM THE ROCKET-LAUNCHER. THE CAR ROLLED

ONTO THE SIDEWALK WITH ITS MOTOR IDLING. THE DECAPITATED CHAUFFEUR LAY IN THE STREET, THE OTHER TWO BODIES IN THE CAR. AT 10:10, AFTER EXCHANGING FIRE WITH THE POLICE GUARDS, FIVE OR SIX OF THE ATTACKERS SPED AWAY IN THE PICKUP. AT 10:12 THE ASSASSINS STOPPED THEIR TRUCK A BLOCK AWAY AND COMMANDEERED A PASSING CAR DRIVEN BY AN ARCHITECT, THREATENING HIM WITH THEIR MACHINEGUNS. POLICE OFFICIALS ARRIVED AT 10:40. PARAGUAY'S BORDERS WERE ORDERED SEALED, THE AIRPORT WAS CLOSED, AND A NATIONWIDE SEARCH BEGAN. ON THE NIGHT OF 18 SEPTEMBER THE POLICE RAIDED THE HOUSE WHERE YRURZUN WAS LIVING IN ASUNCION. HE WAS KILLED WHILE ATTEMPTING TO ESCAPE OVER A GARDEN WALL. (U)

TWO NICARAGUAN DIPLOMATS WHO ARRIVED IN ASUNCION IN JULY 1980 AND WERE DECLARED PERSONA NON GRATA IN MID-AUGUST BECAUSE ''THEY DID NOT PERFORM THEIR DUTIES'' ARE SUSPECTED OF BEING LINKED TO THE PREPARATION OF THE CRIME. THE CHIEF OF PARAGUAY'S INVESTIGATING TEAM HAS DECLARED THAT THE MACHINEGUNS AND THE ROCKET LAUNCHER USED IN THE MURDER CAME FROM NICARAGUA. HE HAS NOT OFFERED FURTHER INFORMATION ON THIS ASSERTION. UNCLASSIFIED

ON FEBRUARY 6, 1980 IN SWITZERLAND THE TURKISH AMBASSADOR WAS SLIGHTLY INJURED WHEN SHOTS WERE FIRED AT HIS CAR AS HE WAS DEPARTING THE BRITISH EMBASSY IN BERN. AN ARMENIAN GROUP CLAIMED RESPONSIBILITY FOR THE ATTACK. LOCAL POLICE DETAINED THREE MEN IN CONNECTION WITH THE INCIDENT.

MARSEILLES POLICE ARRESTED FRENCH CITIZEN MAX KILINDJAN FOR THE ATTEMPT TO KILL TURKISH AMBASSADOR IN SWITZERLAND. HE IS MOST LIKELY A MEMBER OF THE ARMENIAN SECRET ARMY FOR THE LIBERATION OF ARMENIA.

ITEM NUMBER 8641 CONTAINS DATA OF TYPE - CONFIDENTIAL -- OFFICIAL USE ONLY

ON 31 JULY 1980 IN ATHENS, GREECE, AN UNIDENTIFIED GUNMAN SHOT AND KILLED A TURKISH DIPLOMAT. GALIP OZMEN, AN ATTACHE AT THE TURKISH EMBASSY WAS SITTING IN HIS CAR WITH HIS FAMILY WHEN THE GUNMAN FIRED REPEATEDLY INTO THE BACK WINDOW. ONE DAUGHTER, 14 YEARS OLD DIED OF HER INJURIES, OZMEN'S WIFE AND SON WERE SERIOUSLY INJURED. ANOTHER SON ESCAPED INJURY. AN ANONYMOUS CALLED CLAIMED RESPONSIBILITY FOR THE KILLINGS ON BEHALF OF THE ARMENIAN SECRET ARMY. THIS WAS THE FIRST ASSASSINATION IN ATHENS BY THE ARMENIAN SECRET ARMY WHICH HAS KILLED TURKISH DIPLOMATS IN OTHER EUROPEAN CAPITALS. (UNCL)

ON 3 JANUARY 1980 IN LIMASSAL, CYPRUS HANI AL-HINDI (ALIAS ABU MAHMUD), A FOUNDER OF THE ARAB NATIONALIST MOVEMENT WITH GEORGE HABBASH AND LATER A MEMBER OF THE PFLP WITH HABBASH, WAS SERIOUSLY INJURED BY A BOMB THAT EXPLODED IN HIS CAR. AL-HINDI, WHO IS DESCRIBED AS A SYRIAN JOURNALIST BASED IN BEIRUT WHO RAN THE INSTITUTE FOR ARAB RESEARCH, SUFFERED THE LOSS OF HIS LEFT ARM IN THE EXPLOSION. HE WAS FLOWN TO BEIRUT ON 4 JANUARY ON A MIDDLE EAST AIRWAYS CHARTERED AIRCRAFT WITH A PALESTINIAN MEDICAL TEAM IN ATTENDANCE. PRESS REPORTING INDICATES THAT A CANADIAN HAS BEEN ARRESTED IN CYPRUS IN CONNECTION WITH THE ATTACK. (U)

ON 21 MAY 1980 IN DAMASCUS, SYRIA, ONE SOVIET  
AND POSSIBLY MORE, WAS KILLED WHEN HIS VEHICLE WAS  
FIRED UPON AND THEN BOMBED. TOTAL NUMBER OF CASUALTIES  
IS UNKNOWN. (CONF)

ITEM NUMBER 9044 CONTAINS DATA OF TYPE - CONFIDENTIAL

ON 2 JUNE 1980 IN NABLUS, ISRAEL, AN IGNITION BOMB EXPLODED IN THE CAR OF MAYOR SHAKA. SHAKA LOST BOTH LEGS IN THE EXPLOSION. THE PRESS REPORTS THAT INVESTIGATORS ARE 'NEAR CERTAIN' THAT JEWISH EXTREMISTS ARE TO BLAME. A GROUP CALLED 'SONS OF ZION' CLAIMED RESPONSIBILITY. A SPOKESMAN FOR 'ISRAEL'S FREEDOM FIGHTERS--TERROR AGAINST TERROR' SAID HIS GROUP SUPPLIED THE EXPLOSIVES FOR THE ATTACK. THE EXPLOSIVE CHARGES WERE STANDARD IDF ISSUE.

DOCTORS AT RAFEDIYA HOSPITAL SAID A POISONOUS SUBSTANCE IN THE EXPLOSIVES HAD CAUSED INFECTION AND THAT SPECIAL TREATMENT WAS NEEDED. SHAKA REFUSED AN OFFER BY THE MILITARY GOVERNMENT OF TREATMENT IN ANY ISRAELI HOSPITAL. HE WAS MOVED ACROSS THE JORDAN RIVER BY AMBULANCE WHERE HE WAS MET BY A JORDANIAN HELICOPTER WHICH TRANSFERRED HIM TO THE KING HUSSEIN MEDICAL COMPLEX. (UNCL)

ON 3 SEPTEMBER 1981 IN NEW YORK, USA, EXPLOSIVE DEVICES WERE FOUND UNDER AUTOMOBILES BELONGING TO THE USSR MISSION TO THE UN.. THERE WAS NO EXPLOSION. A TELEPHONE CALL CLAIMED RESPONSIBILITY FOR THE JEWISH DEFENSE LEAGUE. (CONF, LOU)

ITEM NUMBER 8812 CONTAINS DATA OF TYPE - CONFIDENTIAL -- OFFICIAL USE ONLY

UNCLASSIFIED

ON 4 SEPTEMBER 1981 IN NEW YORK, USA, A SMALL BOMB EXPLODED UNDER A CAR PARKED NEAR THE SOVIET MISSION TO THE UN. THE VEHICLE--OWNED BY A MEMBER OF THE NIGERIAN UN MISSION--WAS DAMAGED BY WHAT LOCAL POLICE BELIEVE WAS A MOLOTOV COCKTAIL. NO INJURIES WERE REPORTED. A MAN CLAIMING TO BE A MEMBER OF THE JEWISH DEFENSE LEAGUE (JDL) CALLED UPI AND CLAIMED THAT GROUP UNDERTOOK THE BOMBING TO GAIN RELEASE OF SOVIET DISSIDENTS. IN TWO DAYS SEVEN BOMBS WERE DISCOVERED IN THE AREA OF THE SOVIET MISSION (THE JDL CLAIMED RESPONSIBILITY FOR ALL OF THE BOMBS), ONLY ONE OF WHICH WENT OFF. AROUND 1900, ERDEYLI GOT INTO HIS CAR TO DRIVE TO WORK BUT TRAVELED ONLY A FEW FEET BEFORE THE EXPLOSION. THE ENGINE AND FENDER WERE DAMAGED BUT ERDEYLI ESCAPED INJURY. THE ARMENIAN SECRET ARMY FOR THE LIBERATION OF ARMENIA HAS TAKEN RESPONSIBILITY FOR BOTH ATTACKS. (U)

THE GENERAL AND HIS WIFE, WHO ACCOMPANIED HIM, SUFFERED MINOR CUTS AND TEMPORARY HEARING PROBLEMS. THE OTHER OCCUPANTS OF THE CAR, THE GENERAL'S MILITARY AIDE AND A WEST GERMAN POLICE OFFICIAL WHO ACTED AS DRIVER, WERE NOT INJURED. (UNCL)

IN SPITE OF THE NATURE OF THE ATTACK, THE CAR REMAINED OPERABLE. ONE GRENADE PENETRATED THE TRUNK OF THE ARMOR-PLATED VEHICLE AND EXPLODED, BLASTING UP THE TRUNK LID AND SHATTERING THE REAR WINDOW. THE SECOND GRENADE MISSED THE CAR AND CARVED A FOOT-DEEP HOLE IN A NEARBY SIDEWALK. A HAIL OF SMALL-ARMS FIRE, SOME OF WHICH STRUCK THE CAR, FOLLOWED THE GREANDE ATTACK. (U)

GENERAL KROESEN'S CAR HAD BEEN PROCEEDING FROM HIS HOME TO HIS OFFICE IN HEIDELBERG WHEN THE AMBUSH OCCURRED. THE TERRORISTS, ACCORDING TO AVAILABLE REPORTING, DID NOT TARGET A SECOND VEHICLE, THE MILITARY ESCORT CAR, WHICH WAS FOLLOWING AT AN UNSPECIFIED DISTANCE BEHIND THE FLAG CAR. REPORTS VARY ON WHETHER THE GENERAL'S CAR WAS MOVING OR WAS STOPPED FOR A TRAFFIC SIGNAL AT THE TIME OF THE ATTACK. (U)

(GUDRUN ENSSLIN WAS ONE OF THE EARLY LEADERS OF THE RAF, DURING THE PERIOD WHEN IT WAS GENERALLY KNOWN BY ITS POPULAR NAME OF 'BAADER-MEINHOF GANG.' SHE COMMITTED SUICIDE, ALONG WITH ANDREAS BAADER AND JAN-KARL RASPE, IN STAMMHEIM PRISON RIGHT AFTER THE FAILURE OF THE

THE PATRIARCH AND HIS PARTY WERE PROCEEDING VIA AUTOMOBILE TO DAMASCUS WHEN ANOTHER VEHICLE OVERTOOK THEM AND THE ASSAILANTS OPENED FIRE WITH SUBMACHINEGUNS. THE PATRIARCH SUFFERED ONLY A SUPERFICIAL FACE WOUND, AND ALTHOUGH THE CAR WAS REPORTEDLY RIDDLED WITH BULLET HOLES, THERE WERE NO OTHER CASUALTIES. ACCORDING TO PRESS REPORTS, THE ATTACKERS UTILIZED A RED MERCEDES AND HAD WAITED NEAR AN ARAB DEFENSE FORCE CHECKPOINT FOR ABOUT AN HOUR BEFORE THE PATRIARCH'S VEHICLE ARRIVED. (U)

IN CALLS TO LOCAL NEWSPAPERS, A GROUP CALLING ITSELF 'THE FRONT FOR THE LIBERATION OF LEBANON FROM FOREIGNERS' CLAIMED CREDIT FOR THE INCIDENT. THE GROUP STATED IT HAD NOT TRIED TO KILL THE PATRIARCH BUT THAT THE ATTACK WAS A WARNING TO LEADERS AND OFFICIALS THAT 'THEY SHOULD SAY ABROAD WHAT THEY SAY AT HOME.' IN ADDITION TO CLAIMING CREDIT FOR THE BOMBING OF SEVERAL CARS IN PALESTINIAN AREAS OF BEIRUT IN LATE 1980, THE GROUP ALSO CLAIMED RESPONSIBILITY FOR THE 27 AUGUST 1980 AMBUSH OF US AMBASSADOR JOHN GUNTHER DEAN'S MOTORCADE. (U)

IT IS INTERESTING TO NOTE THAT IN THE ATTACK AGAINST AMBASSADOR DEAN, THE ASSAILANTS UTILIZED A 'MAROON' MERCEDES. THIS GROUP EITHER HAS A PENCHANT FOR RED MERCEDES VEHICLES OR IS DELIBERATELY UTILIZING SUCH CARS AS ITS CALLING CARD. (S)

ON 17 DECEMBER 1980, IN SYDNEY, AUSTRALIA, TWO GUNMEN ON A MOTORCYCLE ASSASSINATED TURKISH GENERAL CONSUL SARIK ARIYAK AND HIS BODYGUARD. DRESSED IN COVERALLS AND HELMETS, THE ASSASSINS FIRED AUTOMATIC PISTOLS THROUGH THE WINDOWS OF THE CAR, HITTING EACH VICTIM SEVERAL TIMES. (U)

EARLY REPORTS INDICATE THAT WITHIN AN HOUR OF THE SHOOTINGS A WOMAN 'WITH A FOREIGN ACCENT' CALLED THE AUSTRALIAN ASSOCIATED PRESS AND CLAIMED RESPONSIBILITY FOR THE ACT ON BEHALF OF THE JUSTICE COMMANDOS OF THE ARMENIAN GENOCIDE. THE CALLER ADDED THAT THE GROUP'S REVOLUTIONARY MOVEMENT STARTED IN 1975 WITH ACTS BY COMMANDOS IN VIENNA, ROME, MADRID, PARIS AND THE VATICAN IN RETALIATION FOR INJUSTICES TO ARMENIANS BY TURKS IN 1915. THE CALLER EMPHASIZED THAT HER GROUP 'HAS NO CONNECTIONS WITH THE SO-CALLED ARMENIAN SECRET ARMY' AND THAT THE GROUP'S ATTACKS ARE AIMED AT TURKISH DIPLOMATS AND TURKISH INSTITUTIONS. (U)

THE OTHER ARMENIAN ATTACK WAS ATTEMPTED IN LONDON BY THE 'OCTOBER THIRD' GROUP. IN PICCADILLY, ABOUT MIDNIGHT, BETWEEN 15 AND 16 DECEMBER, POLICE DEFUSED WITHOUT INJURY TWO SMALL BOMBS (REPORTED TO CONTAIN 500 AND 600 GRAMS OF SEMTEX) OUTSIDE A BUILDING SHARED BY THE FRENCH TOURIST AND FRENCH RAILWAY OFFICES. THE POLICE HAD BEEN ALERTED AFTER TELEPHONE CALLS BY TWO SEPARATE CALLERS TO REUTERS AND THE UPI. BOTH CALLERS WERE UNDER THE IMPRESSION THAT THE BOMBS HAD ALREADY EXPLODED. THE CALL TO REUTERS WAS MADE BY A MAN WITH AN 'APPARENT FRENCH ACCENT' WHO ANNOUNCED: 'WE ARE THE OCTOBER THIRD. WE ARE RESPONSIBLE FOR THE DESTRUCTION OF FRENCH TOURISM AND FRENCH RAILWAY. THIS IS A WARNING TO THE FRENCH FASCISM AGAINST HER ATTITUDE INVESTIGATING OUR COMRADES IN GENEVA. THANK YOU.' HE THEN READ A STATEMENT IDENTICAL TO ONE READ BY THE OTHER CALLER. ASKED ABOUT 'OCTOBER THIRD', HE SAID THAT IT WAS 'A MILITARY ORGANIZATION AND YOU WILL HEAR A LOT MORE FROM US'. (U)

THE OCTOBER THIRD GROUP HAS CLAIMED RESPONSIBILITY FOR A SERIES OF BOMBING ATTACKS, CHIEFLY IN LONDON, PARIS, ROME AND GENEVA. BY FAR THE GREATEST NUMBER OF THESE HAVE BEEN DIRECTED AGAINST SWISS INSTALLATIONS BECAUSE OF THE FACT THAT THE SWISS HAVE SINCE 3 OCTOBER BEEN HOLDING IN INVESTIGATIVE CUSTODY TWO ARMENIAN TERRORIST SUSPECTS WHO, IN A GENEVA HOTEL ROOM, WERE PREPARING CIGARETTE PACKAGE BOMBS WHEN ONE OF THESE PREMATURELY EXPLODED. THE CASE HAS DURING THE LAST FEW WEEKS BEEN GIVEN WIDE COVERAGE IN THE SWISS PRESS AND IN THE U.S. ARMENIAN PRESS, WITH VARYING DEGREES OF ACCURACY. (U)

IT IS QUITE LIKELY THAT THE 'OCTOBER THIRD' GROUP WILL CONTINUE TO ATTACK SWISS TARGETS, FRENCH TARGETS AND TARGETS OF ALL NATIONALITIES, INCLUDING THE U.S., WHICH THE GROUP JUDGES TO BE INVOLVED IN ANY KIND OF INVESTIGATION OF THE ARMENIAN SECRET ARMY FOR THE LIBERATION OF ARMENIAN (ASALA) OR ANY OTHER ARMENIAN TERRORIST GROUP. ONE OF THE PRISONERS IN SWITZERLAND IS A U.S. CITIZEN, THE OTHER A LEBANESE. (U)

IN ADDITION, REGARDLESS OF ORGANIZATIONAL DISTINCTIONS SUCH AS THE ONE JUST MADE IN AUSTRALIA, ARMENIAN TERRORISTS ARE LIKELY TO ATTEMPT ANOTHER ASSASSINATION OF A TURKISH DIPLOMAT OR MEMBER OF HIS FAMILY, AS SUCH ATTACKS IN THE PAST HAVE FREQUENTLY BEEN STAGED IN CLUSTERS. (U)

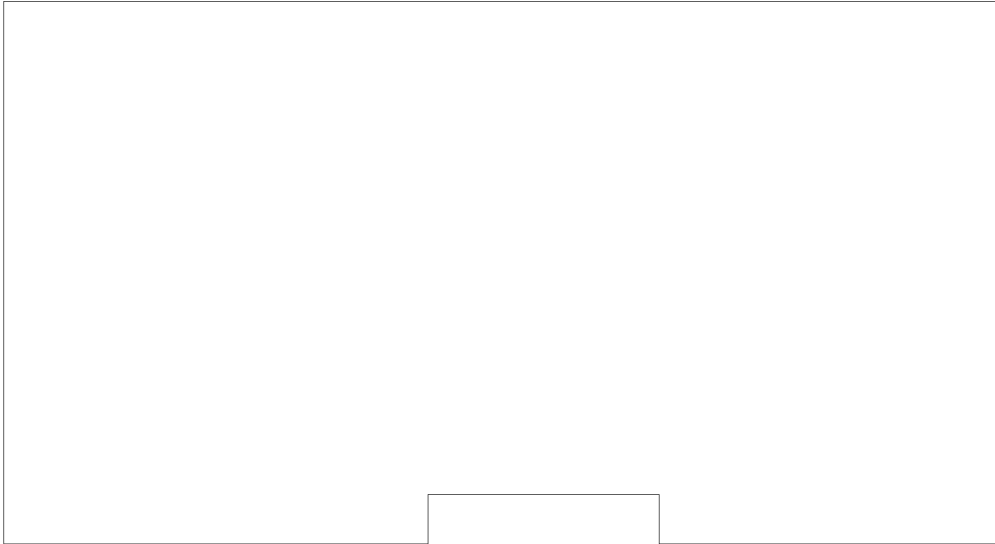

THE DIPLOMAT'S CAR WAS ARMORED SO HE CAME OUT OF THE ATTACK UNSCATHED. THE TERRORISTS FARED LESS WELL: ONE WAS SERIOUSLY WOUNDED AND CAPTURED DURING THE ENSUING SHOOTOUT IN WHICH THEIR GETAWAY CAR WAS RUN TO BAY BY POLICE. THE OTHER THREE TERRORISTS ESCAPED ON FOOT AND REMAIN AT LARGE.

AGENCE FRANCE PRESSE IN BEIRUT RECEIVED A TELEPHONE CALL IN WHICH CREDIT FOR THE ATTACK WAS CLAIMED BY THE 'RED ARMENIAN ARMY.' THE CALLER ISSUED A WARNING TO DUTCH AUTHORITIES AGAINST IMPRISONING THE CAPTURED TERRORIST ONE PENYAMIN EVINGULU, A 22-YEAR-OLD TURKISH NATIONAL WHO RELOCATED TO LEBANON ON 1966. HE WAS NOT PREVIOUSLY KNOWN.

THE 'RED ARMENIAN ARMY' HAS NOT BEEN HEARD OF BEFORE. IF IT IS CONNECTED WITH EITHER OF THE TWO KNOWN ARMENIAN TERRORIST GROUPS--THE ARMENIAN SECRET ARMY FOR THE LIBERATION OF ARMENIA (ASALA) OR THE JUSTICE COMMANDOS OF THE ARMENIAN GENOCIDE (JCAG)--WHICH IS LIKELY, 'RED' WOULD ALIGN IT CLOSER TO THE MARXIST-LENINIST ASALA RATHER THAN THE ANTI-COMMUNIST JCAG. SEVERAL CARS WERE DAMAGED AND WINDOWS IN NEARBY RESIDENCES WERE SHATTERED. AGENCE FRANCE-PRESSE RECEIVED A CALL FROM A MAN IDENTIFYING HIMSELF AS THE FUGITIVE LEADER OF DIRECT ACTION, JEAN-MARC ROUILLAN, WHO CLAIMED HIS GROUP WAS RESPONSIBLE FOR THE BOMBING. A SUBSEQUENT CALLER DENIED RESPONSIBILITY FOR THAT GROUP. (UNCL) (WSRIT, 21 AUG 82)

RECENT ADDITIONAL DETAILS INDICATE THAT THE BOMB WAS ATTACHED TO THE VEHICLE BY MAGNETS. WHEN THE FAMILY USED THE CAR TO TAKE THEIR SON TO THE AIRPORT, THE BOMB APPARENTLY FELL OFF, WITHOUT EXPLODING. (UNCL) (NC 9293275)

ALL OFFICIAL MEMBERS OF THE TURKISH CONSULATE GENERAL ARE BEING FULLY PROTECTED. NO THREATS HAD BEEN RECEIVED AGAINST ARIKAN.

FOUR SUSPECTS HAVE BEEN SUBSEQUENTLY ARRESTED (ALL OF WHOM ARE OF ARMENIAN DESCENT AND BORN IN LEBANON). THE WEAPONS USED IN THE ATTACK WERE ONE COLT 45 AUTOMATIC, AND A COLT NINE. BOTH WEAPONS WERE RECOVERED AT THE SCENE AND ARE BEING HELD AS EVIDENCE. (UNCL)

AN UNIDENTIFIED CALLER TO THE AP BUREAU IN LOS ANGELES CLAIMED THE JUSTICE COMMANDOS FOR THE ARMENIAN GENOCIDE WAS RESPONSIBLE FOR THE ASSASSINATION. THE HANDGUNS WERE A .357 MAGNUM AND A BROWNING 9MM PISTOL.

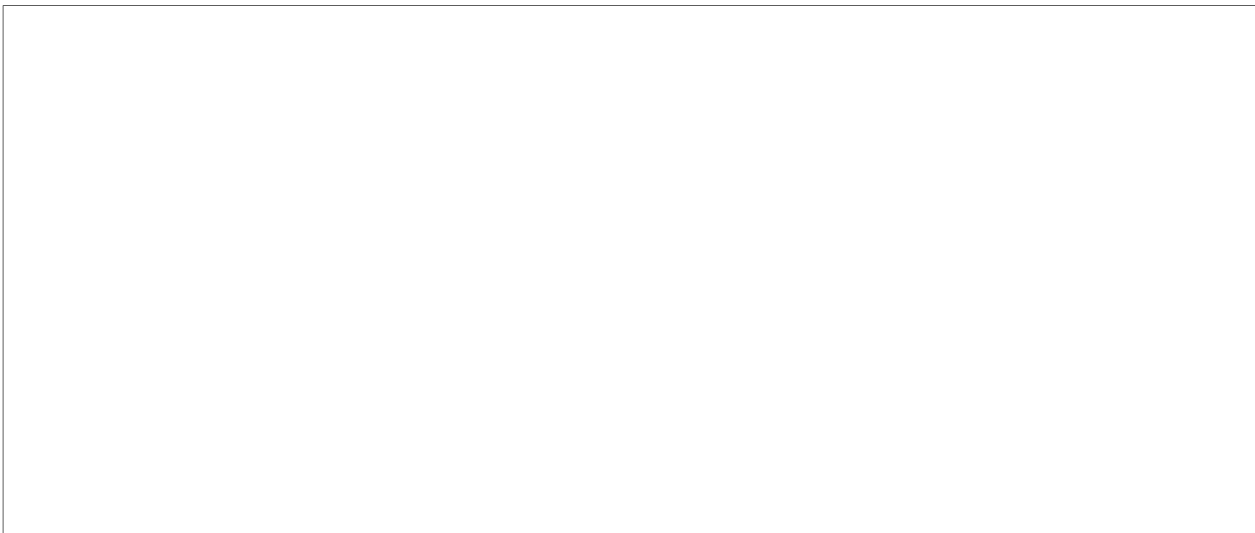

THE PERPETRATORS IDENTIFIED THEMSELVES AS MEMBERS OF THE REVOLUTIONARY ORGANIZATION OF THE PEOPLE (ORP). BOGOTA'S LOCAL NEWSPAPER 'EL BOGOTANO' REPORTEDLY RECEIVED A COMMUNIQUE FROM THE ORP WHICH CONTAINED A PHOTOGRAPH OF BISHOP STANDING IN FRONT OF A BLACK FLAG WITH THE LETTERS ORP PRINTED IN RED. 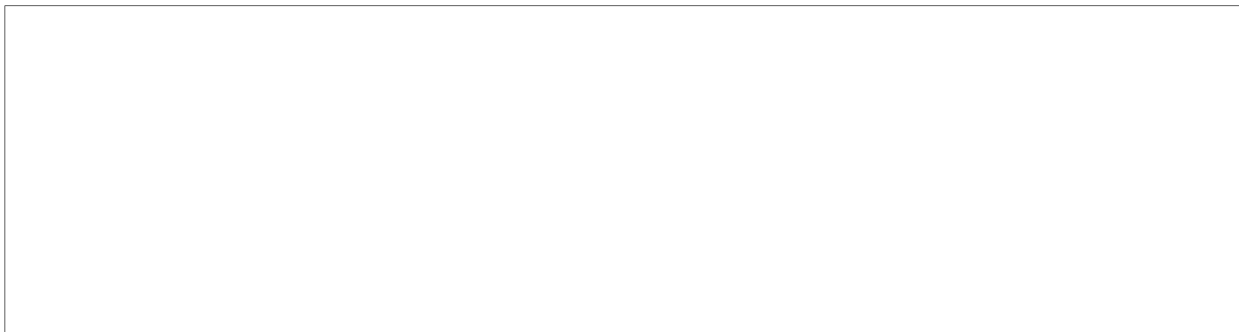

HOWEVER, THE BOMB EXPLODED WHILE IT WAS BEING PLACED AND A TERRORIST BY THE NAME OF SULTAN GREGORIYANN SEMATERDEM DIED.

IN A PHONE CALL TO THE AFP OFFICE IN TEHRAN, ASALA CLAIMED RESPONSIBILITY FOR THE INCIDENTS AND AFFIRMED THAT THE ATTACKS WERE A REPRISAL FOR THE 1983 MURDER OF MILITANT ARMENIANS IN THE REGION OF THE BIQA VALLEY IN LEBANON, IN WHICH THE TURKISH SECRET SERVICES WERE ALLEGEDLY INVOLVED.

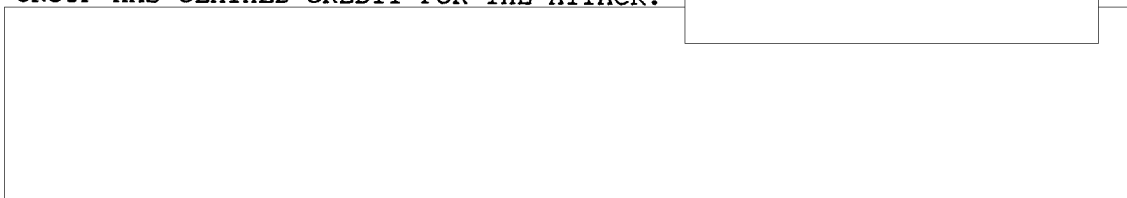
