1. CONFIDENTIAL-ENTIRE TEXT.

2. THIS MORNING I TOOK CODEL MONTGOMERY TO MEET WITH MINISTER OF WAR LE. GENERAL OSCAR BRUSH NOEL. WE TOOK OPPORTUNITY AT MEETING TO STRONGLY DENY CURRENT PRESS STORIES IN LIMA TO EFFECT THAT US PLANS MASSIVE ARMS SALES, INCLUDING PERSHING MISSILES, TO CHILE. DURING MEETING GENERAL BRUSH CONFIDENTIALLY PASSED TO ME ALLEGED STATE DEPARTMENT AIRGRAM REGARDING SALES, WHICH APPEARS TO BE CLEAR FORGERY

ARMS TRANSFERS POLICY: SALE OF DEFENSE EQUIPMENT/SERVICES TO CHILE ON OCTOBER 22, 1981, THE SENATE RECOMMENDED TO EXCLUDE CHILE FROM THE ITAR LIST OF COUNTRIES WHICH ARE DENIED LICENSES FOR EXPORTS OF AMMUNITION FROM THE UNITED STATES AND OTHER CLEARANCES.

AS A RESULT, CHILE HAS GAINED FULL RIGHTS UNDER ITAR PROCEDURES. IN ADDITION, ALL THE ITAR AMENDMENTS AND PROCEDURES PUBLISHED IN ADVISORY LETTER NO. 96 OF SEPTEMBER 1982 ARE APPLICABLE TO CHILE.

THE LIST OF DEFENSE EQUIPMENT APPROVED TO BE TRANSFERRED TO CHILE IN 1983-1984 IS AS FOLLOWS:

1. "STINGER (FIM-92A) PORTABLE ANTI-AIRCRAFT MISSILE, 200 MISSILE LAUNCHING TUBES AND 800 MISSILES.
2. MULTIPLE LAUNCHING ROCKET SYSTEM (MLRS), 12 X 240 MM., 4 UNITS
3. ROCKET LAUNCHER (M91), 115 MM 45, WITH M-55 CHEMICAL ROCKETS (GB) -8 UNITS, AND 4,000 ROCKETS.
4. "LANCE" BATTLEFIELD SUPPORT MISSILE SYSTEM (MGM-52C), WITH M-251 (BG) WARHEADS - 5 UNITS

IN ADDITION, BATTALIONS OF "PERSHING" BATTLEFIELD SUPPORT MISSILES (MGM31-A) SHALL BE TRANSFERRED TO THE CHILEAN ARMED FORCES IN 1984-1985 AFTER THE "PERSHING II" MISSILE BALLISTIC SYSTEMS ARE INSTALLED IN WEST GERMANY.

THE MGM 31-A MISSILES WILL BE PROVIDED TO CHILE AT A SPECIAL DISCOUNT RATE OF OVER 60 PERCENT, AND THE WHOLE TRANSACTION WILL BE COVERED BY A LOAN OF US\$780 MILLION TO CHILE, REIMBURSABLE OVER A PERIOD OF 10 YEARS AT AN ANNUAL RATE OF 8.5 PERCENT.

3. ACTION REQUESTED: PLEASE REVIEW TEXT TO CONFIRM FORGERY. WE PLAN TO PUBLICIZE THIS AS EXAMPLE OF PROBABLE SOVIET DISINFORMATION EFFORT.
