

As you know, the Permanent Subcommittee on Investigations has maintained an historic interest in international narcotics trafficking and money laundering issues. Currently, the Subcommittee is conducting an inquiry into drug related corruption of public officials of foreign countries.

In addition, I would appreciate your sending copies of the latest Special Intelligence Estimates for the following countries: Hong Kong, Laos, Bulgaria, Burma, Thailand, Mexico, Colombia, Ecuador, Bolivia, Peru, Paraguay, Honduras, Jamaica, Bahamas and Cuba. We understand of course, that these materials will be stored at the Senate Select Committee on Intelligence. We look forward to your cooperation on this important subject.
