1. (SWN) SIGNIFICANCE: A PROBABLE ROCKET MOTOR IS IDENTIFIED AT BIYSK SOLID MOTOR TEST AREA II FOLLOWING A RECENT TEST.
2. (SWN) REMARKS: A PROBABLE SOLID ROCKET MOTOR WITH DIMENSIONS [REDACTED] AND A PROBABLE SOLID ROCKET MOTOR/TEST FIXTURE, [REDACTED] (AT OPPOSITE ENDS), ARE OUTSIDE THE LARGE HORIZONTAL TEST CELL. THE SIZE OF THE MOTOR SUGGESTS THAT IT IS ASSOCIATED WITH THE SS-NX-20 SUBMARINE LAUNCHED BALLISTIC MISSILE. THE ENVIRONMENTAL SHELTER WHICH WAS POSITIONED AGAINST THE THRUST BLOCK [REDACTED] IS AT THE ENTRANCE TO THE TEST CELL. A LARGE MOBILE CRANE REMAINS INSIDE THE REVETTED TEST POSITION. THIS POSTTEST ACTIVITY FOLLOWS A ROCKET MOTOR TEST CONDUCTED HERE BETWEEN [REDACTED] [REDACTED] A LARGE BURN MARK EXTENDING APPROXIMATELY 280 METERS FROM THE TEST POSITION WAS OBSERVED ON [REDACTED]
