FRELIET: "Mr. Edmindson, after eight years in the United States foreign service, why did you suidenly decide to attack the U.S. foreign uplicy and resign your position?"

NOMENDON: "Well, I don't think I decided to attack U. S. forign policy; I decided to exercise (the right?) of an American citizen to express his opinion. And why did I do it? I did it because I thought I could serve my country very much better by standing on the outside and making some remarks than I could by staying on the inside. I think there are some things that need to be bettered, need to be corrected, and I hope, in my feeble way that what I've done may help."

MARTIANT: "How long have you held these views? Is this a suiden decision on your part or have you thought this way a long time?"

EDEFINITION: "Well, I've thought this way for some time. I tried to get something done when I was in Afghanistan. If you remember, Afghanisten used to be, I would say, in the American orbit. And now I notice that Charles Sulzborger of the NEW YORK TIMPS said that it may safely be considered to be in the Soviet orbit. I saw that happen. I think I was able to warn in advance that it was going to happen waless

And I think we are somewhat in the same situation now in Karwa, except the fact we have two armed divisions there. I don't think that bades very well for emerica's international future."

PARELIST: "Mr. Edmundson, your statement relates to the fact you said, 'I cannot conscientionally support a foreign policy that will lead us to the brink of an atomic war.' Can you tell us what you referred to in that statement?"

Similarity: "Yes, I referred to the passage of the Hiddle East doctring. I think that to do as much as as propose to do militarily there in the Hiddle Hast, so close to the borders of our particular exercises, and going it alone without the remotion of the United Hations, without the cooperation of any other power, I think that that's danceroue and I don't think it's a safe policy."

PASSILTER: "Well, do you think the Eisenhower Doctrine will lead us into a third world war?"

EDETHISON: "I hope that it won't, but I think there is too great a danger of it."

SUFFLIST: "Fr. Edmandson, I believe that the joint statement of Bulganin and Chou En Lai said this doctrine would start new tensions. To that what you're saying?"

EMERGED: "Well, I don't like to have the words of Communists put in my month. I'm as strongly enti-communist as anyone listening to this program, but I would pay that it will increase tensions, and that it will not accomplish what it's meant to accomplish toward helping us to prevent the spread of Communism."

PRESENT: "Hr. Edmandson, the Senate Committee and the House, after extensive hearings and much debate, have passed the President's Hiddle East destrine; now do you have some information specifically which would cause you to oppose it, which the Senate Committee do not have?"

ETHINISHES: "Well, some of the men in the Senate, and in the House, and especially in the Senate, whose opinions are, I'm inclined very strongly to accept, such as Senator Fulbright, Senator Mansfield. I think they do share my views. Sanator Morse or Oregon, for example. I would personally let the views of those Senators outweigh the views of the rest."

What apscifically is wrong with it in your view?"

EMEMBERSON: "With the Middle Fast doctrine? I think that the thing that is most wrong with it is this. That the United States in the United Sations is committed to taking action in the international community, not unilaterally, but multi-laterally, and multi-laterally through the United Nations. Now when the President and France and Britain move in on Maypt about two months ago, we denounced France and Britain for doing that, and we forced them to back down, through the power of the United States, the influence moral and physical of the United States to back down. And now I find only a month or two later that we are doing precisely the same thing, we're taking precisely the same unilateral action as we denounced when Britain and France took it. (SEC) And I don't think that that is consistent, I don't think it makes us friends in the World, I don't think it makes for world peace."

PANSLIST: "Mr. Edmindson, vien you handed newspapermen on your staff in Tokyo--when you handed them this strictly personal statement,

you charged that profiteers, gratters and politicians around the sorid see sothing hold of United States aid funds. Well, now don't you think that you could be promoting the Soviet Union with potential propaganda?"

Engenerations: "No, I don't think so at all. In the first place, that was slightly misquoted, I believe, in the papers. I looked up what T said after that appeared, and I don't think that I said 'around the world.' in some nations, I think, the international Cooperation administration is doing a good job. In many mations, I don't thick that it is. Your question was, was I giving potential propagande to the other side. I thought that ever very carefully. And I thought that if the Soviete, for example, could wash timir filthy lisen in public, as they did in the domunciation of Stalin, perhaps as should have the courses to wash some of our mildly disvolated lines in public ourselves (if) that's marally advantageous for us."

antitation "Sell, the world is very large. If my memory serves no. it's about 27 or 29 thousand miles around, and it seems to me that we would never for one moment think of Allowing the Soviet Salon to come and (set up?) bases in Mexico and Control America and even South America. Then some effort was made by the Communists to take over Guaterala, the

CENTRAL INTELLIGINES AGREET and other elements of the American government --the American government defense system very quickly repulsed that. I think that a case could be made that another great nation on the other side of the globe from us has at least something of the same right to protect itself from quick attack, quick atomic attack, that we have to protect ourselves from quick atomic attack when we went into Custemala."

CAMELINT: "Well, Mr. Edmundson, you speak of this joint action and discrement, would you also be in favor of complete discrement in withdrawing troops from Germany and disbudding MATO and things of that sort, in line with what you just said?"

DEMANDORY: "well, let us make it clear, Mr. Fatterson, I make no protension to emmiscience at all. I have see or two fields in which I have some competence, but your question there is far too sweeping for me to attempt to answer, particularly in 30 minutes."

DESELIET: "Hr. Edmindson, your atomic bases statement concerns the expect that how would you defend the nation without these bases that we have?"

ENERGISEN: "Well, I'm is favor of having storic bases. I'm in forer of strong military defense for the United States. There's no argument between as and the disonhower administration about that at all, but there may be some argument as to whether we should press closer and closer toward the boundaries of our potential energy, taking atomic bases and atomic artillery under the noses of these nations, when we would not for one minute allow them to come within a thousand miles of us. The Soriptures, I believe, say something about doing to others as you would

have others do unto you, and I admit that the Christian doctrine just desen't serve as a code in this particular world we live in, but it seems to have some common sense relevance."

MANY: "Mr. Edankalson, at what point--where would you draw the line-how many miles from Hunsis, for example, would you say it was norsh to put an stomic base?"

For 30 years the United States had preached about the sacred sanctions of international law, of moral law, against the killing of non-commatants. And there at Hiroshima and Nagasaki, we dropped the atomic bomb, as i said in that statement, on babies, on children, on maidens and mothers,

on the aged and infirm, without any thought of what we'd been practicing, of what we'd been preaching for 30 years."

reseller: "Mr. Edwardson, do you have any basis for stepping now into the military judgmont--I mean, do you have any background to go into judgmonts along those lines?"

ENGLISHER, "Yes, I do have a slight basis, well, more than a slight basis. I think that Hanson Haldwin, the military attache of the WHETCH THEM, is recognized as one of the great military authorities--certainly one of the great civilian military authorities, although he had military training himself, and maldwin has written an article in the ATLANTIC Monthly in which he said the dropping of the bombs was a mistake, wanneesmary in order to win the war, and I was a war correspondent around the world in most of the theatres of war at one time or another during the Second World War. I followed the thing closely, and I den't think it was necessary."

PLERIGHT: "Well, why have you waited til now to bring this out, according like 11 or 12 years aco?"

But in this particular statement, when my conscience drove so to the point of view where i could no longer conscienciesly support the foreign policy, then I did have a right to make a statement, and I did make a statement."

FRANKLEW: "Sir, in your statement to the press, the Chi figured wery prominently and you had one statement concerning the reporters being herred from Red Ching, and you said that one of the reasons was bhat the State Department might fear that reporters might upset diplometic applecarts. That did you have is mind by that statement?"

FIRENDSOS: "Well, I quoted in my statement-I quoted the United Press as saying the State Department feared we might uppet diplomatic applecarts, and I don't know what applecarts are there, but I have an ides. New the United States says that it will not take any means toward extending trade relations with Communist China because they're still holding ten Americans prisoners there. And it just so happens that I know and the CIA knows, of course, and the Communisty China's government knows that some of those ten people at longt are members of the Contral Intelligence Agency and perhaps of other intelligence agencies. And it's pessible that one reason the State Department does not want American correspondents in there is that they might interview there people and it might come out in public intelligence that some of those mon vers intelligence agents. And that might woman the Saited States's case. I'm saying it now, and shy an I saying that? I'm saying it because in the first place no here can be densy the Chinese know it and some informed Americans who can read between the lines mow that some of these people--certainly Fectors and Bosmey, two of the men who are beld-are CIA mon. And I think that distorts the whole picture of international relations to have intelligence man held, when the whole world, especially the United States, thinks that it's simple innocent American citizens who are held. Now those men are innocent but they're also intelligence agents."

PANELIST: "Well, you said (that?) should be brought out into plain sight. Now did you mean just that because it seems to me the Central Intelligence Agency by its very nature would have to have many things kept secret, so were you referring only to this situation where the teo

men you mentioned are CIA agents were being held prisoner, or did you mean the whole operation of the Control Intelligence Agency?"

ENMINDSON: "Well, Mr. Patterson, it's quite obvious in this particular sphere of world affairs you have to have spies, you have to have intelligence agents, you have to have good ones. And I know Mr. Allen Bulkes, and I have known him for nearly 20 years, and let we say that I consider him an extremely able public servant, and a very patriotic one, but I do think the CDA is making a mistake in this respect: when some of its people get caught, that then the American--that the country that catches them treats them as it has every right to treat them under international law, them when these people, these agents, are portrayed to the interican people as simple, innocent interican businessmen and what not, and the emotions of the American people are lacerated and internated by their thinking that these are just ordinary citizens, then I think that you cause tensions and you ereste a national atmosphere that is the very essence of the kind of atmosphere that could lead a mation into war. Do I make agent?"

HAUT: "Yes, we have some reactions here from our youngsters."

PARELIST: "What about Congressional investigation? Do you approve of Senator Manafield's proposals for congressional control of the CIA?"

EDMENDIOR: "Oh, yes, absolutely. I thought it was a bad day in the Senate when the Senate voted down Senator Manafield's resolution to ast up a watchdog committee to look after the CIA. I think it's against the genius of democracy; it's particularly, I think, Mr. Cooper, Against the genius of American institutions to have a great secret agency, which is subterranean, which the public knows nothing about,

to have it operate without any reasonably (sefe?) or democratic control. And that's the way the CIA is operating here now. Now many people are operating? I don't know. Have you any idea how many CIA agents are deployed around the world?"

PANELIST: "Aren't you going to/question of history of our country? Nen't that the way it's always been done? Can you tell specifically we had <u>A</u> number of spins, is that what you're advocating?"

EDMUMDSOR: "No, I'm not advocating that, but I am anying as a very minimum there should be some device, such as Semantor Manafield tried to set up in the watchdag committee. Now I have here an article in the CATURDAY EVENTHE POST on the CIA. Not much is written about the Central Intelligence Agency but in 1953 bick Harkmess's wife wrote a thrme-part series on the CIA, and they estimate---they and TIME magazine too--here's TIME magazine--it estimates the number of CIA agents deployed around the world as between 8,000 and 30,000. Now to take even a conservative average of those two--now you have CIA agents equal to about two alimented down infantry divisions. And that's an antel lot of people that you one operate to carry out may phantasy that the world may originate."

HAUT: "Mr. Edmandson, do you have firsthand knowledge of any other situation in which you feel the CIA MAS been injurious to our foreign pelicy or injurifous to the best interests of America?"

EDECHDSCH: "Yes, there are two or three I could name. Perhaps the most flagrant is that when the CIA, when intelligence agents were supporting several thousand Nationalist Chinese troops up in the (Shen?) province, which is the Shan province of Barma. And up there you had an irresponsible military force. They were attacking with importiality

the Chinese Communists one day, and U Hu's troops the next, and they were causing complications which resulted in the death of the Thailand people up there in that corner of the world, and that went on for four or five years. And finally, we had, if you recall, I suppose it was two or three years ago, we had a four-power conference. There wasn't such in the papers about it, but the conference was held arguer at Bangkok, and the four powers represented were Barma, Mationalist China, United States, and Thailand. And the countries concerned, Burns and Theiland, put so much pressure on us, that we sent transport planes in there and flew those troops out. But for several years before that, we had supported them with American military supplies flown in from Formers; the operation, I believe--I've been told by what I considered a good authority-was known as "Western Frontier." We had American officers up there is uniform; we had, I believe, some German-some deserters from the French Foreign Legion that we were paying to help that-that Nationalist Chinese force, and it was a very (unsafe?) and, I would say, unsavery situation."

PARELIST: "Me". Edmandson, I'm sorry but you've been a live vague in some of your statistics. Could you give us some sources for the points you've just brought out?"

EDMUNISOR: "Now which statistics am I vague on?"

PANELIST: "Well, on her long the war lasted, how many men were involved, so on and so forth."

EUROREEON: "Yes, the thing went on from 1952 to-from 1952 to 1956. I went down to the Congressional Library yesterday and I went through the NEW YORK TIMES files for about four years, and they had references

to this Nationalist Chinese force up there, and its depredations and its complications over a period from 1952 to 1956. Now what other statistics? I'd like to get that straightened out?"

PANELIST: "Well, I was just wondering--you mentioned something about deserters from the French and German armies--I was wondering--

SDMENDROWN "No. Deserters from the French Foreign Legion. There were three of those--at least there were three of them whose pictures after they were dead and corpose that were taken by Burmese photographers and were published in Burmese mewapapers and Bangkok merspapers. I don't have copies of those papers here---

PARELIST: "Nr. Edmundson, you stated that President Disenhower has to turn his back upon the United Nations and take upon America's shoulders along the task of preserving peace in the world. You've undoubtedly read his address this weak-ond on the Midsast crisis and do you now feel you'd like to withdraw your previous criticism?"

EREMINENT "No, I don't think his address dealing with that would do anything to contradict what I said."

PANELIST: "Mr. Edwandson, may I say to you then that you said President Eisenhouser wants to turn his back on the United Nations and Wednesday might be told this nation that the United Nations must not fail. New how can you still maintain that position?"

EDEDEDECH: "Well, words of -- the President -- let me not be put in the position of being disputations toward -- being unnecessarily disputations toward the President. I have respect for him. I've known him since he was a colonel; as a war correspondent, I've known him since he was a colonel. And nevertheless, regardless of what was said in that

speech to which you referred, I would say when we agree unilatorally to guarantee the Middle Eastern mations against Soviet aggression, they maintain by that action, regardless of what anybody said, regardless of whe it is that said it, we have turned our back on the United Mations."

PAMELIST: "Well, in emother area, you said in your resignation, and I'm quoting, 'Profiteers, grafters and politicians around the world are getting hold of U. S. aid funds.' Gould you be specific about that, who, and what avidence you have?"

NDMONENCEN: "I didn't say 'around the world." I answered that point a while ago. You have a messageper elipping and 'around the world' is inscouracy. But in Kores, where I'm very intiastely acquainted with what is happening, I'll say without any fear of (contradiction?), that the rich are getting richer and the poor are getting power and the grafters are getting more money, and that our aid program there is not accomplishing its purpose of binding the Kerean people to our side, any more than our aid to Chiang Kai Shek on the Chinese mainland in 1945-6-7-8 accomplished the purpose of binding the Chinese mainland in 1945-6-7-8 accomplished the purpose of binding the Chinese people to us. SDEENDEROR: "Well, I don't want to try to consit or interpret my fellow employees in any country, but I will say this: that after I

made my statement--I don't think I was pariah before I made them, but when I want back to Korsa, I think I sensed a certain varaness that I'd never sensed before. Some people came up to me, even to my house, several of them did and came repeatedly, and shock my hand and said you've been saying many things that we've been wanting to see said for a long time."

EDMINDSON: "Well, I was called on to make a statement to some representatives of the Senate Conmeittee on Fereign Aid and I was told I'd be called on in March."

PANELIST: "Mr. Edmondson, I understand that you were in Secul, Korea, and you want up to Tokym to make this statement--any particular reason?"

MDMURDEON: "That is not at all true. I'm glad you bring that up. I was in Secul, Kerea, and I did not seek this trip to Tekyo, but [--" HAGT: "Our time has just run out."
