1. The following sanitization request is made in an effort to contribute to a debriefing interrogation being conducted of

The debriefing is being conducted by representatives of the Director of Security, CIA, in conjunction with a team from OSI/USAF.

2. The two select pieces of TALENT material to be utilized will undergo the following sanitization procedures:

a. Vertical photographs, cropped and enlarged with all fiducial markings removed. Focal length not disclosed. Year not specified. Scale 1:10,000 to 1:11,000. Reproduction will be of a 9 x 9 format with no reference to TALENT or CHESS.

b. Classification: The classification of the two prints, although SECRET NOFORN, will be contained one each in three booklets only; these booklets will contain certain GX and other CIA photography maps and [REDACTED]. The three booklets will be classified TOP SECRET and continuous receipts will be required. One copy will be disseminated to the D/DCI; one copy to the Director of Security and one copy to the USAF for DI/USAF.


