REMOTE VIEWING (RV) SESSION CD-83

1. (S/NOFORN) This report documents a remote viewing session conducted in compliance with a request for information on a target of interest to USI.

2. (S/NOFORN) The protocol used for this session is detailed in the document, Grill Flame Protocol, AMSAA Applied Remote Viewing Protocol (S) undated.

3. (S/NOFORN) At TAB A is a summary of the data presented by the remote viewer during the session. A complete transcript of the session is available upon request. At TAB B are drawings made by the remote viewer reference his impressions of the target site. At TAB C is target cuing information provided the remote viewer.

1. (S/NOFORN) The following information was provided during an interview of the source at 0900 hrs on 11 Jul 80 (S).

SG1A

a. The source claimed to have observed [REDACTED] dismounting from a large bus in a downtown Manhattan type area. He was seen moving rapidly across a wide sidewalk to a broad expanse of steps leading to a very large, tall building. The bus appeared unique in that it had protrusions fore and aft on the roof that looked somewhat like TV antennae (see drawing #1).

b. (S/NOFORN) The source claimed to have subsequently seen [REDACTED] on top of the building leaning against a railing. The entire observation deck appeared to be inclosed by chain link netting.

c. (S/NOFORN) The source stated that he saw a tall suave white-haired gentleman approach [REDACTED] at the rail and talked with him. The source did not hear the conversation.
