The air drop activities are ongoing now and are to take place by the twenty fifth of May. A parcel of cocaine will be delivered to the air drop off point of 25°N 73°W. The [ ] and the cigarette boat are not both directly involved in the transporting of the drugs. The cigarette boat will transport the limited amount of cocaine to 23°N - 74°W and from this area in the bahamas it will continue around several of the islands. The drugs will not be stashed on the [ ] The parcel of cocaine is stored in green wrapping.
