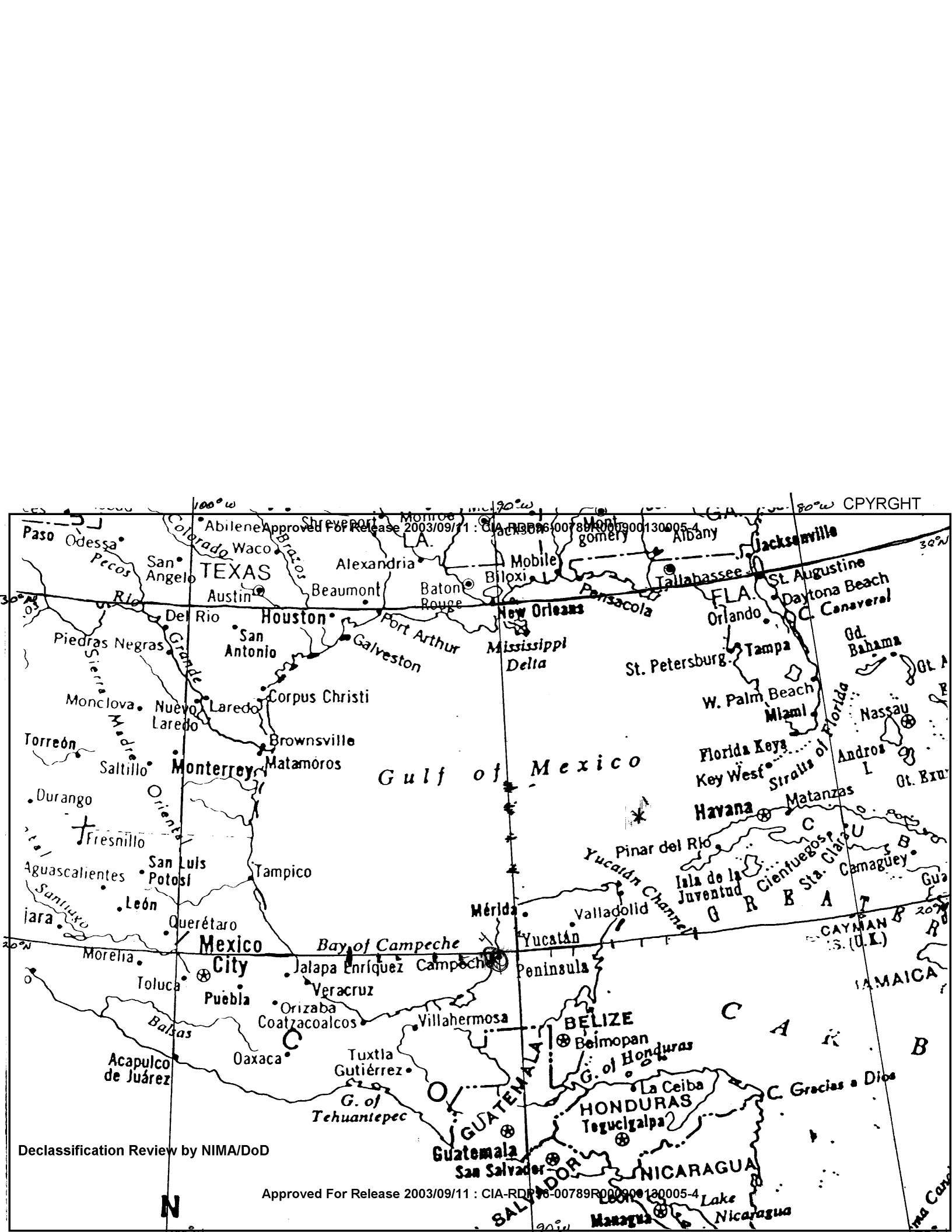
The current (24 1100L May 90) location of the vessel is in the Gulf of Mexico at 26 09' N 90 00 W, heading 51 degrees.
