2. (S/STD/NF) 025 reported the vessel's current (09 1445L APR 90) location as 21 N 178 W. The vessel is heading southeasterly towards Johnston Atoll.
3. (S/STD/NF) 032 reported the vessel's current (09 1545L APR 90) location as 35 00'N 179 09' E.
4. (S/STD/NF) Located at TAB A is a map showing all the points and approximate routes of the vessel(s) provided by all viewers. Located at TAB B are the viewers' session summaries.
