E. SESSION SUMMARY:

The target is currently preparing a small fishing vessel. He is personally involved with the on-sea aspect of this particular operation. He is well groomed and wears his hair in a pony tail.

He has an American companion with him; this person is a very large man with a bushy, reddish-brown beard. This American is pre-occupied with something hanging off of the dock and down into the water.

The vessel feels like a somewhat old wooden fishing boat. The back portion of the boat is open and there is a dearth of ancillary objects present i.e. benches, bait holding tank, fishing nets, pullies, etc.; the usual inventory found on a small time, commercial fishing boat.
