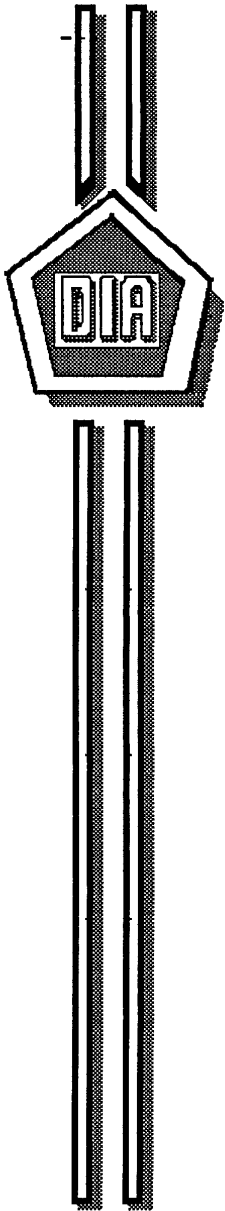

(U) PREFACE:

(S/NF/SG/LIMDIS) The Special Activity Report is the tenth in a series of reports which provides data in response to a request from Joint Task Force Five (JTF-5) in Alameda, California. The data provided in this report will be used by the J22 division in their assessment effort regarding their counterdrug mission. The information provided in this report was generated by PAG-TA employing remote viewing (RV) methodologies.

SG1A (S/NF/SG/LIMDIS) The data provided in this report is the tenth in a series of taskings. This project concentrated on the target [REDACTED]. The results were forwarded to JTF-5 by secure fax on 20 May 1994. The JTF-5 evaluation feedback is at Appendix B.


